LOANS GUARANTEE (DECLARATION OF BODIES CORPORATE)  
(SENTUHAN BUDIMAN SDN. BHD.) ORDER 2015

IN exercise of the powers conferred by section 3 of the Loans Guarantee (Bodies Corporate) Act 1965 [*Act 96*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Loans Guarantee (Declaration of Bodies Corporate) (Sentuhan Budiman Sdn. Bhd.) Order 2015**.

(2) This Order comes into operation on 27 November 2015.

**Declaration of application of the Act**

2. The body corporate known as Sentuhan Budiman Sdn. Bhd. is declared to be a body corporate to which the Act applies.
