PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA KUALA LUMPUR-PUTRAJAYA) (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kuala Lumpur-Putrajaya) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 15 Oktober 2015.

Pindaan am

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kuala Lumpur-Putrajaya) 2008 [*P.U. (A) 15/2008*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dengan menggantikan perkataan “Kuala Lumpur-Putrajaya” dengan perkataan “Maju Expressway” di mana-mana jua terdapat.

Penggantian Jadual Pertama

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

Bagi maksud mengira bilangan gandar dan roda sesuatu kenderaan, gandar dan roda mana-mana treler yang ditarik oleh kenderaan itu hendaklah dikira sebagai sebahagian daripada gandar dan roda kenderaan itu.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(KUALA LUMPUR-PUTRAJAYA HIGHWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Kuala Lumpur-Putrajaya Highway) (Amendment) Order 2015**.

(2) This Order comes into operation on 15 October 2015.

General amendment

2. The Federal Roads (Private Management) (Collection of Tolls) (Kuala Lumpur-Putrajaya Highway) Order 2008 [*P.U. (A) 15/2008*], which is referred to as “principal Order” in this Order, is amended by substituting for the words “Kuala Lumpur-Putrajaya” the words “Maju Expressway” wherever appearing.

Substituting of First Schedule

3. The principal Order is amended by substituting for the First Schedule the following Schedule:

"FIRST SCHEDULE

[subparagraph 2(1)]

RATES OF TOLL

(1) <i>Classes of Vehicle</i>	(2) <i>Toll Payable (RM)</i>	
	<i>Salak South Toll Plaza</i>	<i>Putrajaya Main Toll Plaza</i>
1. Vehicle having two axles and three or four wheels (excluding taxi and bus)	2.00	3.50
2. Vehicle having two axles and five or six wheels (excluding bus)	4.00	7.00
3. Vehicle having three axles or more (excluding bus)	6.00	10.50
4. Taxi	1.00	1.80
5. Bus	1.50	2.50

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”.
