PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA BARU PANTAI) (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Baru Pantai) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 15 Oktober 2015.

Penggantian Jadual Pertama

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Baru Pantai) 2004 [*P. U. (A) 157/2004*] dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(NEW PANTAI HIGHWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (New Pantai Highway) (Amendment) Order 2015**.

(2) This Order comes into operation on 15 October 2015.

Substitution of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (New Pantai Highway) Order 2004 [*P. U. (A) 157/2004*] is amended by substituting for the First Schedule the following Schedule:

"FIRST SCHEDULE

RATES OF TOLLS FOR THE CONCESSION PERIOD
FROM 15 OCTOBER 2015 UNTIL 11 MARCH 2030

| 3. Vehicle having three axles or more (excluding bus) | 6.90 | 6.90 | 6.90 |
| 4. Taxi | 1.20 | 1.20 | 1.20 |
| 5. Bus | 1.60 | 1.60 | 1.60 |

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”.
