Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Skim Penyuraian Trafik Kuala Lumpur Barat–Hubungan Penchala) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 15 Oktober 2015.

Penggantian Jadual Pertama

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Skim Penyuraian Trafik Kuala Lumpur Barat–Hubungan Penchala) 2004 [*P.U. (A) 100/2004*] dipinda dengan menggantikan Jadual Pertama dengan Jadual berikut:

(1) <i>Kelas Kenderaan</i>	(2) <i>Tol Kena Dibayar (RM)</i>
1. Kenderaan yang mempunyai dua gandar dan tiga atau empat roda (kecuali teksi dan bas)	3.00
2. Kenderaan yang mempunyai dua gandar dan lima atau enam roda (kecuali bas)	6.00
3. Kenderaan yang mempunyai tiga gandar atau lebih (kecuali bas)	9.00
4. Teksi	1.50
5. Bas	2.00

Bagi maksud mengira bilangan gandar dan roda sesuatu kenderaan, gandar dan roda mana-mana treler yang ditarik oleh kenderaan itu hendaklah dikira sebagai sebahagian daripada gandar dan roda kenderaan itu.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS) (WESTERN
KUALA LUMPUR TRAFFIC DISPERSAL SCHEME HIGHWAY–PENCHALA LINK)
(AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway–Penchala Link) (Amendment) Order 2015**.

(2) This Order comes into operation on 15 October 2015.

Substitution of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway–Penchala Link) 2004 [*P.U. (A) 100/2004*] is amended by substituting for the First Schedule the following Schedule:

“FIRST SCHEDULE
[subparagraph 2(1)]

RATES OF TOLL FOR THE CONCESSION PERIOD
FROM 15 OCTOBER 2015 UNTIL 15 DECEMBER 2031

(1) <i>Classes of Vehicle</i>	(2) <i>Toll Payable (RM)</i>
1. Vehicle having two axles and three or four wheels (excluding taxi and bus)	3.00
2. Vehicle having two axles and five or six wheels (excluding bus)	6.00
3. Vehicle having three axles or more (excluding bus)	9.00
4. Taxi	1.50
5. Bus	2.00

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”.
