PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)  
(PUNGUTAN TOL) (LEBUH RAYA KEMUNING–SHAH ALAM) (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kemuning–Shah Alam) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 15 Oktober 2015.

**Pindaan perenggan 2**

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kemuning–Shah Alam) 2010 [*P.U. (A) 163/2010*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 2(1) dengan memotong perkataan “mengikut tahun-tahun konsesi,”.

**Penggantian Jadual Pertama**

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(KEMUNING–SHAH ALAM HIGHWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Kemuning–Shah Alam Highway) (Amendment) Order 2015**.

(2) This Order comes into operation on 15 October 2015.

**Amendment of paragraph 2**

2. The Federal Roads (Private Management) (Collection of Tolls) (Kemuning–Shah Alam Highway) Order 2010 [*P.U. (A) 163/2010*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 2(1) by deleting the words “according to the concession years,”.

**Substitution of First Schedule**

3. The principal Order is amended by substituting for the First Schedule the following Schedule:

RATES OF TOLL FOR THE CONCESSION PERIOD  
FROM 15 OCTOBER 2015 UNTIL 31 JULY 2047

(1) <i>Classes of Vehicle</i>	(2) <i>Toll Payable</i> (RM)	
	<i>Plaza Tol Seri Muda</i>	<i>Plaza Tol Alam Impian</i>
1. Vehicle having two axles and three or four wheels (excluding taxi and bus)	1.70	0.90
2. Vehicle having two axles and five or six wheels (excluding bus)	3.40	1.80
3. Vehicle having three axles or more (excluding bus)	5.10	2.70
4. Taxi	0.90	0.90
5. Bus	1.20	0.60

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicles.”.
