PADA menjalankan kuasa yang diberikan oleh subseksyen 15(1) Akta Lembaga Lebuhraya Malaysia (Perbadanan) 1980 [*Akta 231*], Lembaga, dengan kelulusan Menteri Kerja Raya dan dengan persetujuan Menteri Kewangan, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Lembaga Lebuhraya Malaysia (Perbadanan) (Pungutan Tol) (Lebuh Raya Pantai Timur Fasa-2) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 1 Oktober 2015.

**Pindaan perenggan 1**

2. Perintah Lembaga Lebuhraya Malaysia (Perbadanan) (Pungutan Tol) (Lebuh Raya Pantai Timur Fasa-2) 2015 [*P.U. (A) 136/2015*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 1(2) dengan menggantikan perkataan “30 September 2015” dengan perkataan “31 Disember 2015”.

**Pindaan Jadual Pertama**

3. Jadual Pertama kepada Perintah ibu dipinda dalam tajuk dengan menggantikan perkataan “30 SEPTEMBER 2015” dengan perkataan “31 DISEMBER 2015”.

HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) ACT

HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) (COLLECTION OF TOLLS)  
(EAST COAST EXPRESSWAY-PHASE 2) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by subsection 15(1) of the Highway Authority Malaysia (Incorporation) Act 1980 [Act 231], the Authority, with the approval of the Minister of Works and with the concurrence of the Minister of Finance, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Highway Authority Malaysia (Incorporation) (Collection of Tolls) (East Coast Expressway-Phase 2) (Amendment) Order 2015**.

(2) This Order comes into operation on 1 October 2015.

**Amendment of paragraph 1**

2. The Highway Authority Malaysia (Incorporation) (Collection of Tolls) (East Coast Expressway-Phase 2) Order 2015 [P.U. (A) 136/2015], which is referred to as the “principal Order” in this Order, is amended in subparagraph 1(2) by substituting for the words “30 September 2015” the words “31 December 2015”.

**Amendment of First Schedule**

3. The First Schedule to the principal Order is amended in the heading by substituting for the words “30 SEPTEMBER 2015” the words “31 DECEMBER 2015”.
