PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 5) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Selangor, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 5) 2015**.

(2) Perintah ini mula berkuat kuasa pada 30 September 2015.

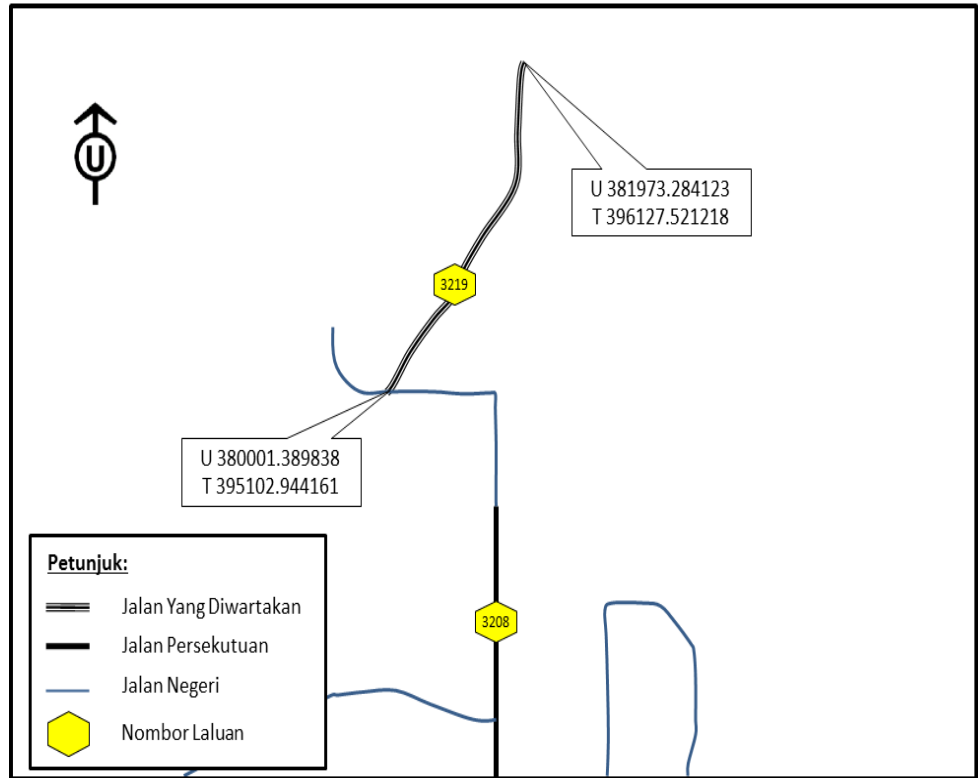
**Pindaan Jadual Keempat**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Keempat—

(a) di bawah kepala “Negeri Selangor Darul Ehsan” dalam butiran 15, dengan menggantikan perkataan “Peta” dengan perkataan “Peta 3”; dan

(b) dengan memasukkan selepas “PETA 2: JALAN PASIR PUTEH-PUSING, NEGERI PERAK” Peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 5) ORDER 2015

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Selangor, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 5) Order 2015**.

(2) This Order comes into operation on 30 September 2015.

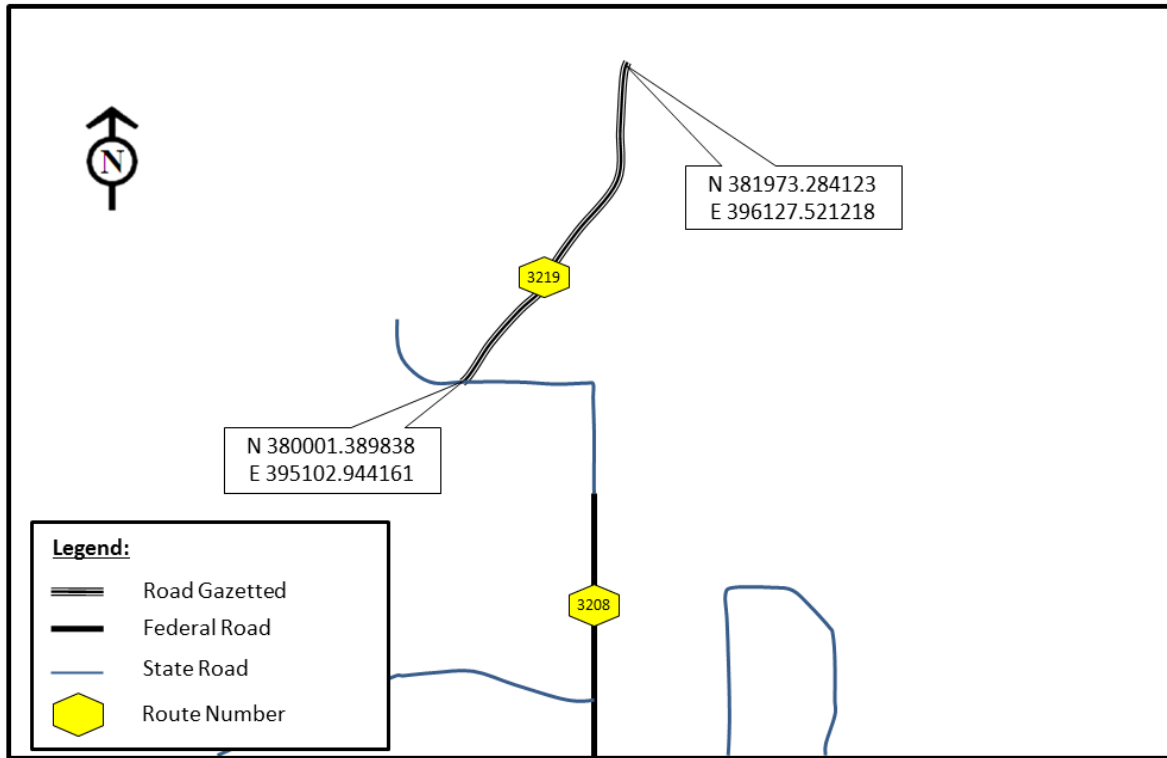
**Amendment of Fourth Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the Fourth Schedule—

(a) under the heading “Negeri Selangor Darul Ehsan” in item 15, by substituting for the word “Map” the words “Map 3”; and

(b) by inserting after “MAP 2: PASIR PUTEH-PUSING ROAD, STATE OF PERAK” the following Map:

“MAP 3: ACCESS ROAD TO KG. TIMAH SKC, BUKIT BERUNTUNG
