PERINTAH PASARAN MODAL DAN PERKHIDMATAN  
(PINDAAN JADUAL 3) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 380 Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Menteri, atas syor Suruhanjaya, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Pasaran Modal dan Perkhidmatan (Pindaan Jadual 3) 2015**.

(2) Perintah ini mula berkuat kuasa pada 15 September 2015.

**Pindaan Jadual 3**

2. Jadual 3 kepada Akta Pasaran Modal dan Perkhidmatan 2007 dipinda dengan memasukkan selepas perenggan 21 perenggan yang berikut:

“22. Mana-mana pengendali pasaran diiktiraf yang aktiviti terkawalanya adalah semata-mata bersampingan dengan pengendalian olehnya suatu pasaran diiktiraf.”.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES  
(AMENDMENT OF SCHEDULE 3) ORDER 2015

IN exercise of the powers conferred by section 380 of the Capital Markets and Services Act 2007 [Act 671], the Minister, on the recommendation of the Commission, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Capital Markets and Services (Amendment of Schedule 3) Order 2015**.

(2) This Order comes into operation on 15 September 2015.

**Amendment of Schedule 3**

2. Schedule 3 to the Capital Markets and Services Act 2007 is amended by inserting after paragraph 21 the following paragraph:

“22. Any recognized market operator where its regulated activities are solely incidental to it operating a recognized market.”.
