AKTA PENJARA 1995

PERATURAN-PERATURAN PENJARA (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 67 Akta Penjara 1995 [*Akta 537*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Penjara (Pindaan) 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 3 September 2015.

**Pindaan peraturan 2**

2. Peraturan 2 Peraturan-Peraturan Penjara 2000 [*P.U. (A) 325/2000*] dipinda dalam takrif “banduan yang belum disabitkan” dalam perenggan (*e*), dengan memasukkan selepas perkataan “Akta Pencegahan Jenayah 1959 [*Akta 297*]” perkataan “atau Akta Pencegahan Keganasan 2015 [*Akta 769*]”.

PRISON ACT 1995

PRISONS (AMENDMENT) REGULATIONS 2015

IN exercise of the powers conferred by section 67 of the Prison Act 1995 [Act 537], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Prisons (Amendment) Regulations 2015**.

(2) These Regulations come into operation on 3 September 2015.

**Amendment of regulation 2**

2. Regulation 2 of the Prisons Regulations 2000 [P.U. (A) 325/2000] is amended in the definition of “unconvicted prisoner” in paragraph (e), by inserting after the words “Prevention of Crime Act 1959 [Act 297]” the words “or Prevention of Terrorism Act 2015 [Act 769]”.
