FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(EAST COAST EXPRESSWAY-PHASE 1) (AMENDMENT) (NO. 3) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (East Coast Expressway-Phase 1) (Amendment) (No. 3) Order 2015**.

(2) This Order comes into operation on 1 September 2015.

**Amendment of First Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (East Coast Expressway-Phase 1) Order 2007 [*P.U. (A) 250/2007*] is amended in the First Schedule by substituting for the words "31 AUGUST 2015" the words "31 DECEMBER 2015".
