(2) Perintah ini mula berkuat kuasa pada 1 September 2015.

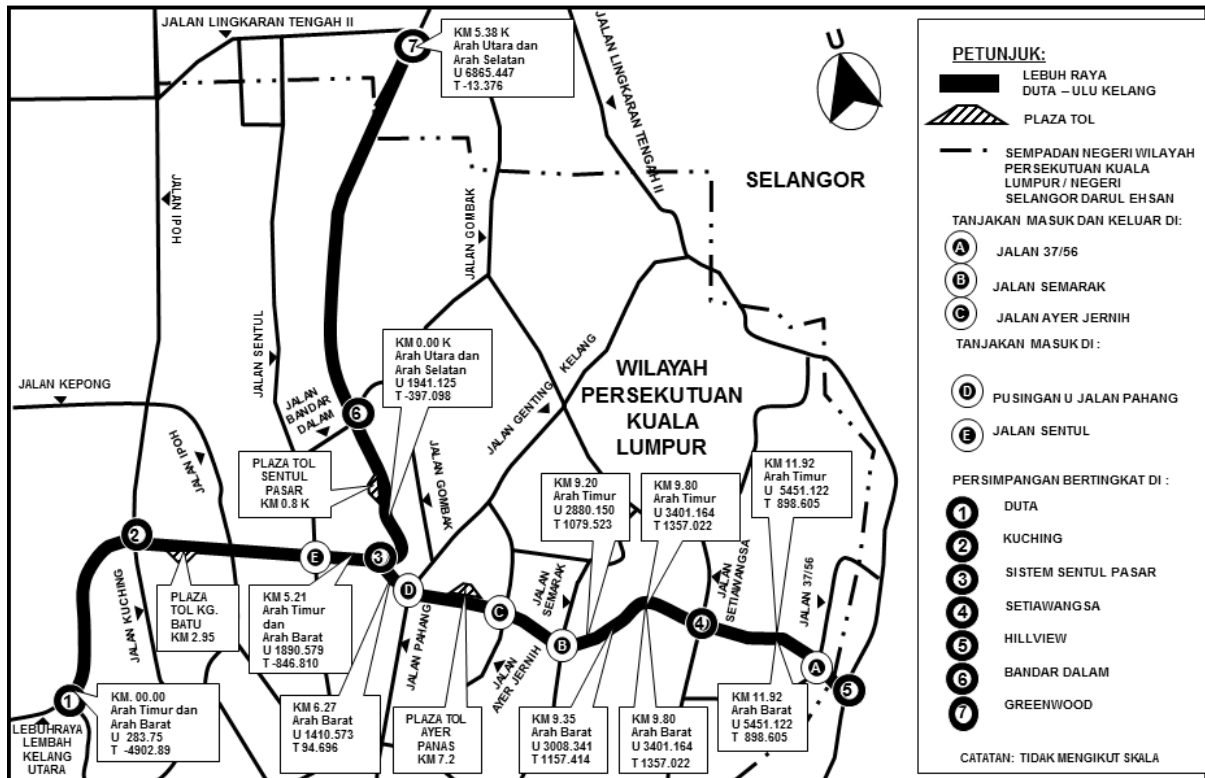

ROAD TRANSPORT ACT 1987

SPEED LIMIT (DUTA-ULU KELANG EXPRESSWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [*Act 333*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Speed Limit (Duta-Ulu Kelang Expressway) (Amendment) Order 2015**.

(2) This Order comes into operation on 1 September 2015.

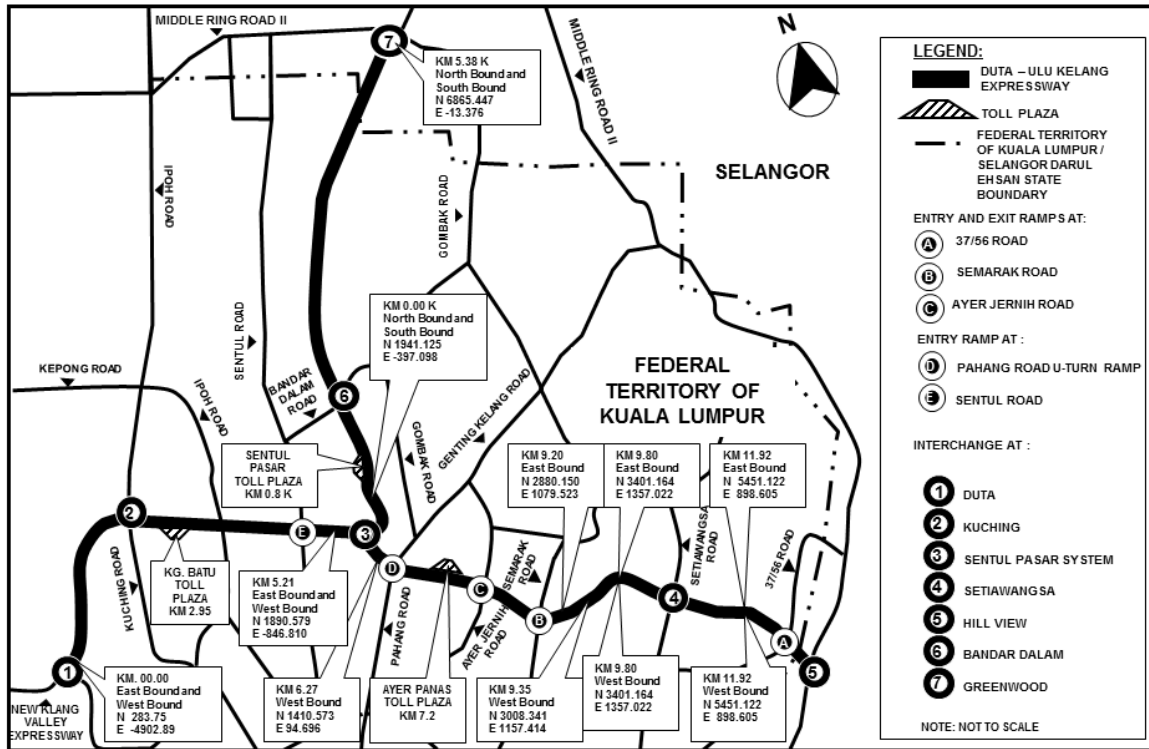
Substitution of Second Schedule
