PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Duta-Ulu Kelang) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2015.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Duta-Ulu Kelang) 2009 [*P.U. (A) 51/2009*] yang disebut “Perintah ibu” dalam Perintah ini dipinda—

(a) dalam subperenggan 2(1), dengan menggantikan perkataan “10 Ogos 2039” dengan perkataan “10 Ogos 2059”; dan

(b) dalam subsubperenggan 2(1)(a), dengan memotong perkataan “, Tanjakan Masuk Jalan Ipoh”.

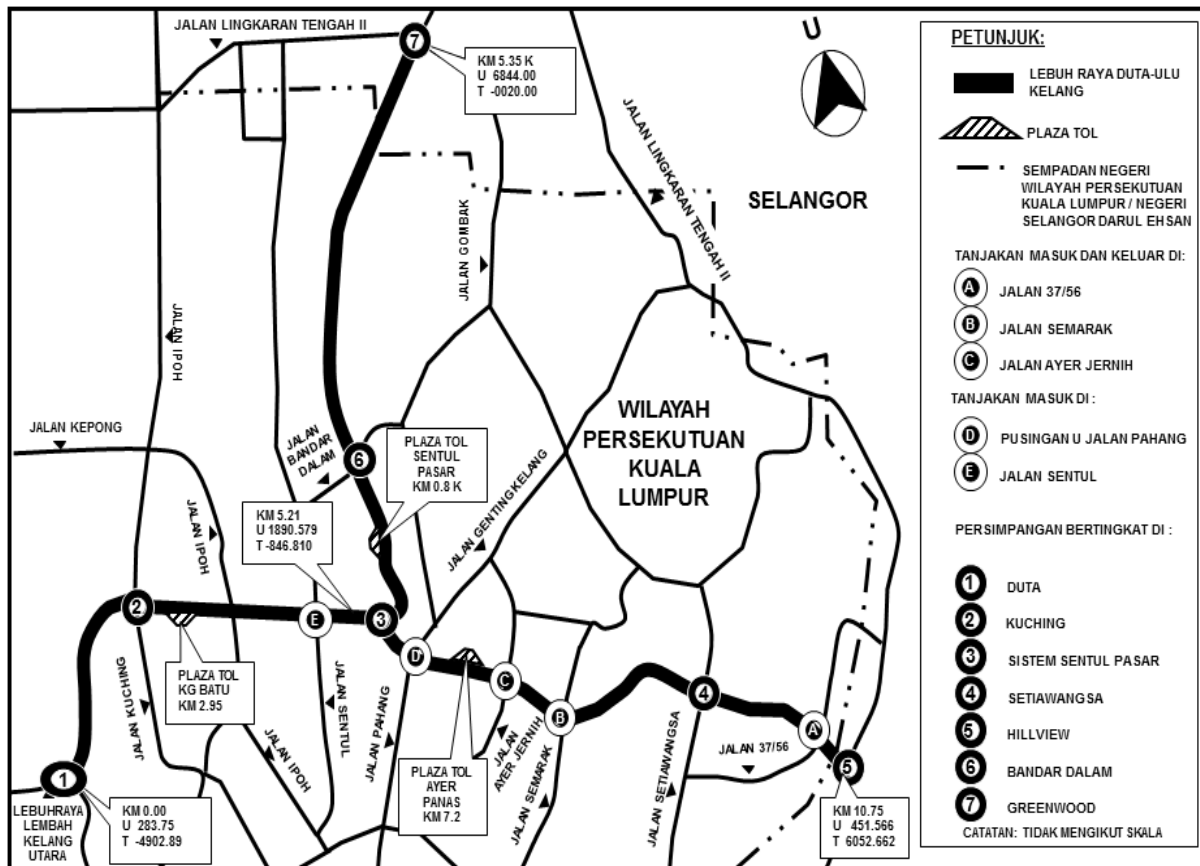

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(DUTA-ULU KELANG EXPRESSWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Duta-Ulu Kelang Expressway) (Amendment) Order 2015**.

(2) This Order comes into operation on 1 September 2015.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Duta-Ulu Kelang Expressway) Order 2009 [*P.U. (A) 51/2009*], which is referred to as the “principal Order” in this Order, is amended—

(a) in subparagraph 2(1), by substituting for the words “10 August 2039” the words “10 August 2059”; and

(b) in subparagraph 2(1)(a), by deleting the words “, Ipoh Road Entry Ramp”.

Amendment of First Schedule

3. The principal Order is amended in the First Schedule in PART II, in the title, by substituting for the words “10 August 2039” the words “31 December 2015”.

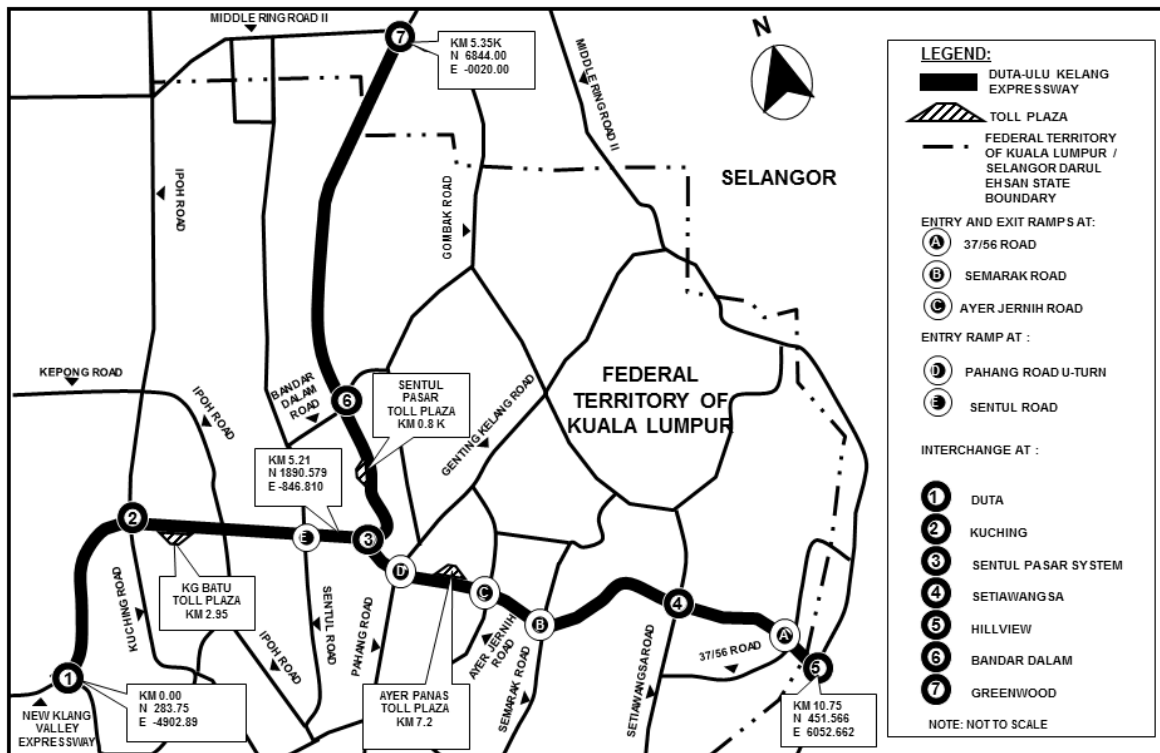
Amendment of Second Schedule

4. The principal Order is amended by substituting for the Second Schedule the following Schedule:
