1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Skim Penyuraian Trafik Kuala Lumpur Barat–Hubungan Kerinchi dan Hubungan Damansara) (Pindaan) (No. 2) 2015**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2015.

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway–Kerinci Link and Damansara Link) (Amendment) (No. 2) Order 2015**.

(2) This Order comes into operation on 1 September 2015.

Amendment of Second Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway–Kerinci Link and Damansara Link) Order 2001 [*P.U. (A) 274/2001*] is amended in the Second Schedule in the heading, by substituting for the words “31 AUGUST 2015” the words “31 DECEMBER 2015”.
