(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Julai 2015.

FEDERAL ROADS (PRIVATE MANAGEMENT)(COLLECTION OF TOLLS)  
(GUTHRIE CORRIDOR EXPRESSWAY)(NO. 2)(AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls)(Guthrie Corridor Expressway)(No. 2)(Amendment) Order 2015**.

(2) This Order is deemed to have come into operation on 1 July 2015.

**Amendment of First Schedule**

2. The Federal Roads (Private Management)(Collection of Tolls)(Guthrie Corridor Expressway)(No. 2) Order 2005 [*P.U. (A) 298/2005*] is amended in the First Schedule in the heading, by substituting for the words “30 JUNE 2015” the words “31 AUGUST 2015”.
