PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian)(Pungutan Tol)(Lebuh Raya Lembah Klang Selatan) (Pindaan) 2015**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Julai 2015.

FEDERAL ROADS (PRIVATE MANAGEMENT)(COLLECTION OF TOLLS)
(SOUTH KLANG VALLEY EXPRESSWAY)(AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls)(South Klang Valley Expressway)(Amendment) Order 2015**.

(2) This Order is deemed to have come into operation on 1 July 2015.

Amendment of First Schedule

2. The Federal Roads (Private Management)(Collection of Tolls)(South Klang Valley Expressway) Order 2013 [P.U. (A) 309/2013] is amended in the First Schedule in the heading, by substituting for the words “30 JUNE 2015” the words “31 AUGUST 2015”.
