PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian)(Pungutan Tol)(Lebuh Raya Damansara–Puchong) (Pindaan) 2015**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Julai 2015.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol)(Lebuh Raya Damansara–Puchong) 1999 [*P.U. (A) 27/1999*] dipinda dalam Jadual Pertama dalam tajuk, dengan menggantikan perkataan “30 JUN 2015” dengan perkataan “31 OGOS 2015”.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT)(COLLECTION OF TOLLS)  
(DAMANSARA–PUCHONG HIGHWAY)(AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls)(Damansara–Puchong Highway)(Amendment) Order 2015**.

(2) This Order is deemed to have come into operation on 1 July 2015.

**Amendment of First Schedule**

2. The Federal Roads (Private Management)(Collection of Tolls) (Damansara–Puchong Highway) Order 1999 [P.U. (A) 27/1999] is amended in the First Schedule in the heading, by substituting for the words “30 JUNE 2015” the words “31 AUGUST 2015”.
