PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 3) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 3) 2015**.

(2) Perintah ini mula berkuat kuasa pada 13 Julai 2015.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala “Negeri Pahang Darul Makmur”—

(a) dengan memasukkan selepas butiran 42 butiran yang berikut:

“43. *(Laluan 34): Jalan Central Spine*

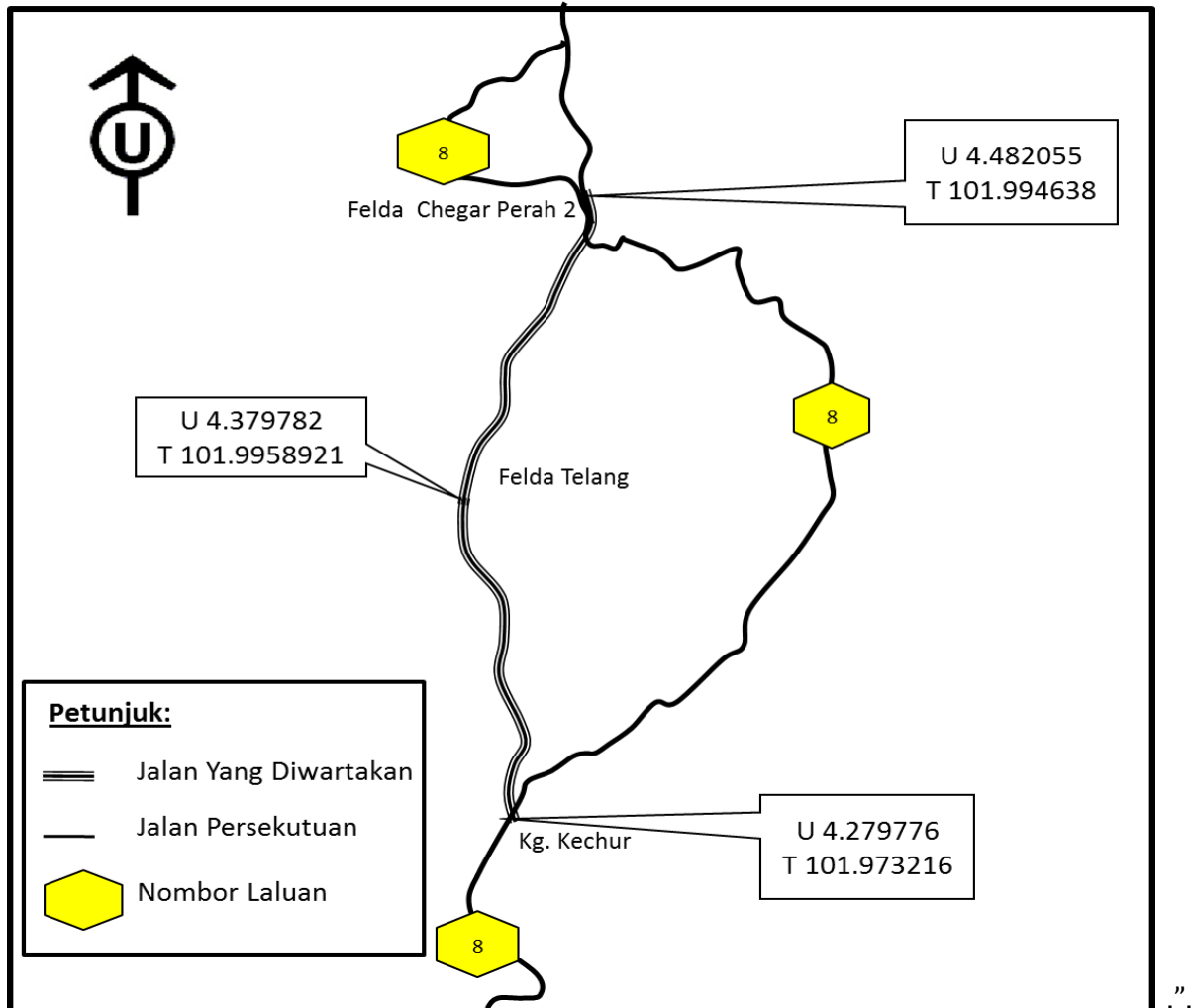
Bermula dari Kg. Kechur di Laluan 8 di koordinat U 4.279776, T 101.973216 dan berakhir di Felda Telang, di koordinat U 4.379782, T 101.9958921 sebagaimana yang ditunjukkan dalam Peta 22: Negeri Pahang (jarak sepanjang 11.9 km).

44. *(Laluan 34): Jalan Central Spine*

Bermula dari Felda Chegar Perah 2 di koordinat U 4.482055, T 101.994638 dan berakhir di Felda Telang, di koordinat U 4.379782, T 101.9958921 sebagaimana yang ditunjukkan dalam Peta 22: Negeri Pahang (jarak sepanjang 12.4 km).”; dan

(b) dengan memasukkan selepas PETA 21: NEGERI PAHANG peta yang berikut:

“ PETA 22 : JALAN CENTRAL SPINE, NEGERI PAHANG

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 3) ORDER 2015

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 3) Order 2015**.

(2) This Order comes into operation on 13 July 2015.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “Negeri Pahang Darul Makmur”—

(a) by inserting after item 42 the following items:

“43. *(Route 34): Jalan Central Spine*

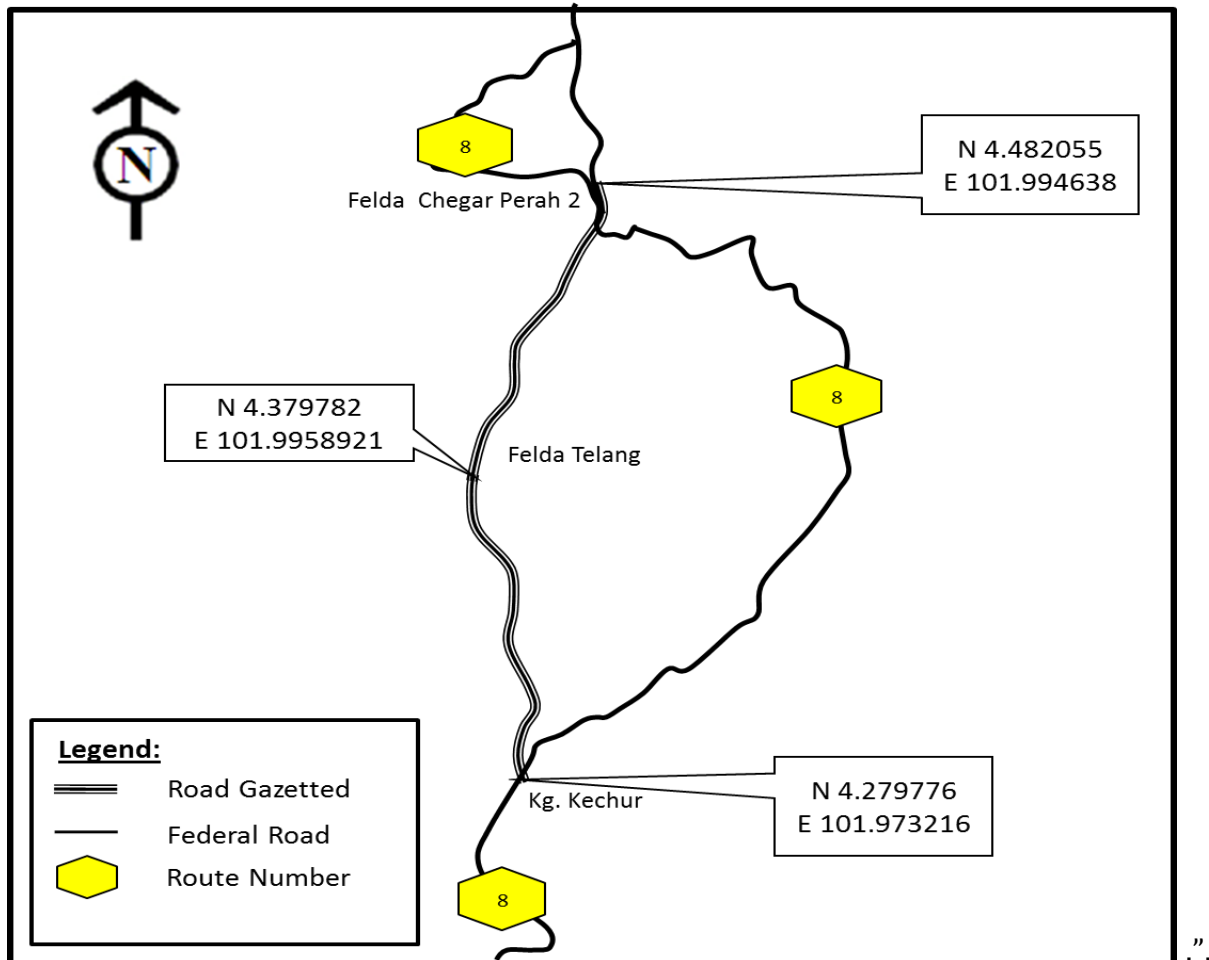
Starting from Kg. Kechur at Route 8 at coordinates N 4.279776, E 101.973216 and ending at Felda Telang at coordinates N 4.379782, E 101.9958921 as shown on Map 22: Negeri Pahang (a distance of 11.9 km).

44. *(Route 34): Jalan Central Spine*

Starting from Felda Chegar Perah 2 at coordinates N 4.482055, E 101.994638 and ending at Felda Telang, at coordinates N 4.379782, E 101.9958921 as shown on Map 22: Negeri Pahang (a distance of 12.4 km).”; and

(b) by inserting after MAP 21: NEGERI PAHANG the following map:

“ MAP 22 : JALAN CENTRAL SPINE, NEGERI PAHANG
