AKTA PENGANGKUTAN JALAN 1987

PERINTAH HAD LAJU TEMPATAN (JALAN PERSEKUTUAN)  
(LARANGAN MASA TERTENTU) (NO. 2) 2015

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(2) Akta Pengangkutan Jalan 1987 [*Akta 333*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Tempatan (Jalan Persekutuan) (Larangan Masa Tertentu) (No. 2) 2015**.

(2) Perintah ini berkuat kuasa mulai 10 Julai 2015 hingga 25 Julai 2015.

**Larangan**

2. (1) Pemanduan kenderaan motor dengan kelajuan yang lebih daripada 80 km/j di atas semua jalan Persekutuan di Malaysia, selain jalan yang dinyatakan dalam Jadual Pertama kepada Perintah Had Laju Tempatan (Jalan Persekutuan) (Malaysia Barat) 1992 [*P.U. (A) 462/1991*], dilarang.

(2) Larangan dalam subperenggan (1) terhenti berkuat kuasa apabila habis tempoh Perintah ini.

ROAD TRANSPORT ACT 1987

LOCAL SPEED LIMIT (FEDERAL ROADS) (SPECIFIED TIME PROHIBITION)  
(NO. 2) ORDER 2015

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Local Speed Limit (Federal Roads) (Specified Time Prohibition) (No. 2) Order 2015**.

(2) This Order has effect from 10 July 2015 to 25 July 2015.

**Prohibition**

2. (1) The driving of motor vehicles at a speed greater than 80 km/h over all Federal roads in Malaysia, other than the roads specified in the First Schedule to the Local Speed Limit (Federal Roads) (West Malaysia) Order 1992 [P.U. (A) 462/1991], is prohibited.

(2) The prohibition in subparagraph (1) ceases to have effect upon the expiry of this Order.
