AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Kelantan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 9 Julai 2015.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala “Negeri Kelantan Darul Naim”—

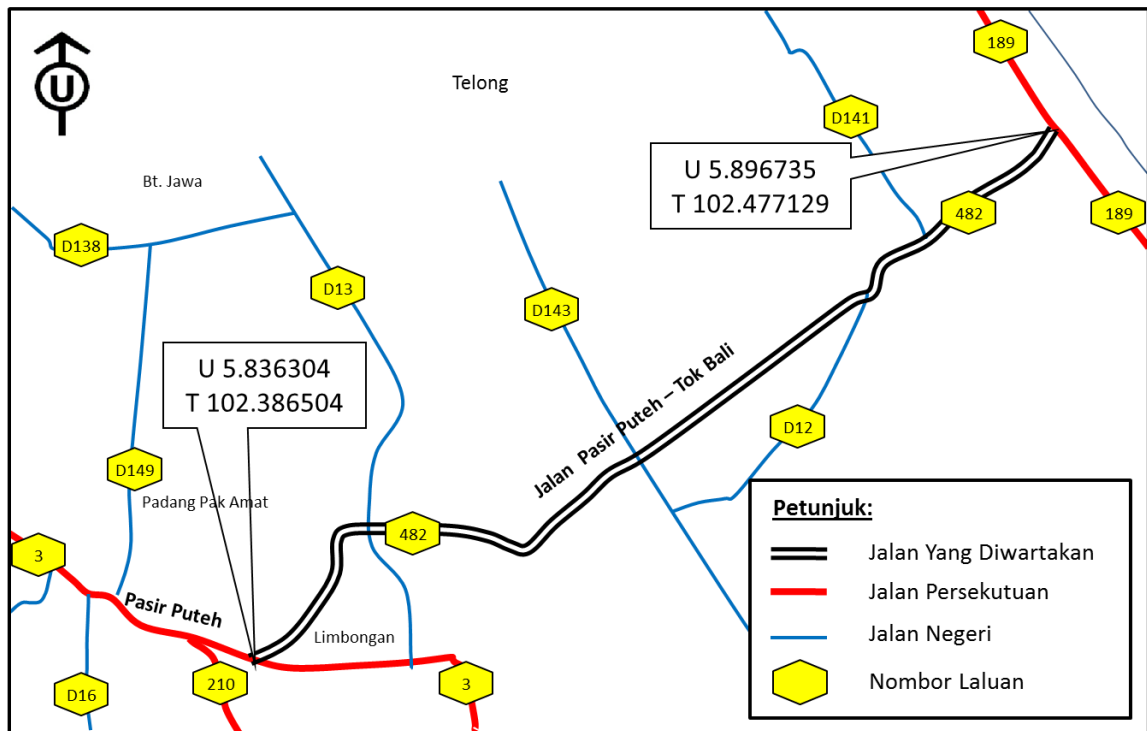
(a) dengan memasukkan selepas butiran 38 butiran yang berikut:

“39. *(Laluan 482): Jalan Pasir Puteh–Tok Bali*

Dari persimpangannya dengan Laluan 3, Jalan Kota Bharu-Kuala Terengganu di Pasir Puteh di koordinat U 5.836304, T 102.386504 dan berakhir di persimpangan dengan Laluan 189, Jalan Pesisir Pantai Kelantan di Tok Bali di koordinat U 5.896735, T 102.477129 sebagaimana yang ditunjukkan dalam Peta 12: Jalan Pasir Puteh-Tok Bali (jarak sepanjang 12.5 km).”; dan

(b) dengan memasukkan selepas PETA 11: JALAN-JALAN PERSEKUTUAN NEGERI KELANTAN peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Kelantan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) Order 2015**.

(2) This Order comes into operation on 9 July 2015.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “Negeri Kelantan Darul Naim”—

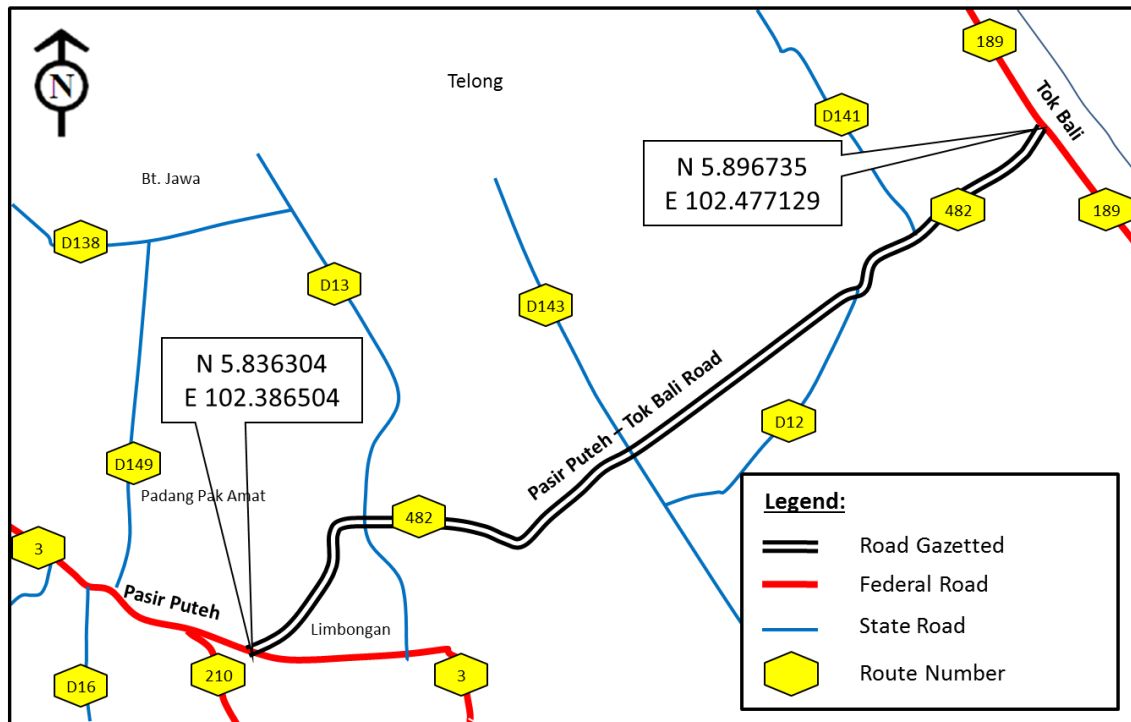
(a) by inserting after item 38 the following item:

“39. *(Route 482): Pasir Puteh–Tok Bali Road*

From its junction with Route 3, Kota Bharu-Kuala Terengganu Road at Pasir Puteh at coordinate N 5.836304, E 102.386504 and ending at its junction with Route 189, Jalan Pesisir Pantai Kelantan at Tok Bali at coordinate N 5.896735, E 102.477129 as shown on the Map 12: Pasir Puteh-Tok Bali Road (a distance of 12.5 km).”; and

(b) by inserting after the MAP 11: FEDERAL ROADS OF NEGERI KELANTAN the following map:
