2. Barang-barang yang dinyatakan dalam Jadual diisytiharkan sebagai barang-barang kawalan bagi tempoh dari 7 Julai 2015 hingga 23 Julai 2015.

7. Ikan kembung termasuk ikan mabung (berat antara 7 ekor hingga 10 ekor setiap kilogram)
8. Ikan selayang (berat antara 7 ekor hingga 10 ekor setiap kilogram)
9. Ikan aya atau tongkol (berat antara 1 ekor hingga 2 ekor setiap kilogram)

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 4) ORDER 2015

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

Citation

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 4) Order 2015**.

Controlled articles

2. The articles specified in the Schedule are declared to be controlled articles for the period from 7 July 2015 to 23 July 2015.

SCHEDULE

CONTROLLED ARTICLES

1. Local beef
2. Imported beef
3. Imported buffalo meat (India)
4. Red chilli
5. Tomato
6. Imported round cabbage (Indonesia and China, not including Beijing cabbage)
7. Indian mackerel (weight ranges between 7 fish to 10 fish per kilogram)
8. Scad (weight ranges between 7 fish to 10 fish per kilogram)
9. Tuna (weight ranges between 1 fish to 2 fish per kilogram)
