PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN (INDUSTRI SKIM  
PERSARAAN SWASTA) (FI) (PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 139ZI dan 139ZJ Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Industri Skim Persaraan Swasta) (Fi) (Pindaan) 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 Jun 2015.

**Pindaan Jadual**

2. Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Industri Skim Persaraan Swasta) (Fi) 2012 [*P.U. (A) 211/2012*] dipinda dalam Jadual—

(a) berhubung dengan butiran 16, dalam ruang "*Perihalan*", dengan memotong perkataan "daripada pematuhan garis panduan atau terma dan syarat kelulusan Suruhanjaya"; dan

(b) dengan memotong butiran 19 dan butir-butir yang berhubungan dengannya.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (PRIVATE RETIREMENT SCHEME INDUSTRY)  
(FEES) (AMENDMENT) REGULATIONS 2015

IN exercise of the powers conferred by sections 139ZI and 139ZJ of the Capital Markets and Services Act 2007 [Act 671], the Commission, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Capital Markets and Services (Private Retirement Scheme Industry) (Fees) (Amendment) Regulations 2015**.

(2) These Regulations come into operation on 15 June 2015.

**Amendment of Schedule**

2. The Capital Markets and Services (Private Retirement Scheme Industry) (Fees) Regulations 2012 [P.U. (A) 211/2012] are amended in the Schedule—

(a) in relation to item 16, in column “*Description*”, by deleting the words “in complying with guidelines or the Commission’s terms and conditions of approval”; and

(b) by deleting item 19 and the particulars relating to it.
