PADA menjalankan kuasa yang diberikan oleh subseksyen 26(2) Akta Pampasan Pekerja 1952 [*Akta 273*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 10 Jun 2015.

**Pindaan Jadual**

2. Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) 2005 [*P.U. (A) 45/2005*] dipinda dalam Jadual—

(a) dengan memasukkan sebelum perkataan “Allianz General Insurance Malaysia Berhad” perkataan “AIG Malaysia Insurance Berhad”;

(b) dengan memasukkan selepas perkataan “Allianz General Insurance Malaysia Berhad” perkataan “AmGeneral Insurance Berhad”;

(c) dengan memotong perkataan “Kurnia Insurance (Malaysia) Berhad”; dan

(d) dengan memotong perkataan “AmG Insurance Berhad”.

WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKERS' COMPENSATION SCHEME)  
(INSURANCE) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [Act 273], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) Order 2015**.

(2) This Order comes into operation on 10 June 2015.

**Amendment of Schedule**

2. The Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U. (A) 45/2005*] is amended in the Schedule—

(a) by inserting before the words "Allianz General Insurance Malaysia Berhad" the words "AIG Malaysia Insurance Berhad";

(b) by inserting after the words "Allianz General Insurance Malaysia Berhad" the words "AmGeneral Insurance Berhad";

(c) by deleting the words "Kurnia Insurance (Malaysia) Berhad"; and

(d) by deleting the words "AmG Insurance Berhad".
