PERATURAN-PERATURAN PERTUBUHAN PELADANG
(PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh seksyen 35 Akta Pertubuhan Peladang 1973 [*Akta 109*], Lembaga Pertubuhan Peladang, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pertubuhan Peladang (Pindaan) 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 25 Mei 2015.

Pindaan am

2. Peraturan-Peraturan Pertubuhan Peladang 1983 [*P.U. (A) 303/1983*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan perkataan “Menteri Pertanian dan Pembangunan Masyarakat Sarawak” di mana-mana jua terdapat dengan perkataan “Menteri Pemodenan Pertanian Sarawak”.

Pindaan peraturan 35

3. Peraturan 35 Peraturan-Peraturan ibu dipinda—

(a) dalam perenggan (1)(c), dengan menggantikan perkataan “lima belas” dengan perkataan “tujuh belas”;

(b) dengan menggantikan subperaturan (3) dengan subperaturan yang berikut:

“(3) Bilangan ahli Jemaah Pengarah yang boleh dilantik oleh Menteri hendaklah tidak melebihi—

(a) empat orang bagi Pertubuhan Peladang Kawasan;

- (b) empat orang bagi Pertubuhan Peladang Negeri;
 - (c) enam orang bagi Pertubuhan Peladang Kebangsaan;
dan
 - (d) tiga orang yang dinamakan oleh Menteri Pemodenan
Pertanian Sarawak bagi Negeri Sarawak.”; dan
- (c) dalam subperaturan (8), dengan menggantikan perkataan “lapan” dengan perkataan “sembilan”.

FARMERS' ORGANIZATION ACT 1973

FARMERS' ORGANIZATION (AMENDMENT) REGULATIONS 2015

IN exercise of the powers conferred by section 35 of the Farmers' Organization Act 1973 [Act 109], the Farmers' Organization Authority, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Farmers' Organization (Amendment) Regulations 2015**.

(2) These Regulations come into operation on 25 May 2015.

General amendment

2. The Farmers' Organization Regulations 1983 [P.U. (A) 303/1983], which are referred to as the "principal Regulations" in these Regulations, are amended by substituting for the words "Minister of Agriculture and Community Development of Sarawak" wherever appearing the words "Minister of Modernisation of Agriculture of Sarawak".

Amendment of regulation 35

3. Regulation 35 of the principal Regulations is amended—

(a) in paragraph (1)(c), by substituting for the word "fifteen" the word "seventeen";

(b) by substituting for subregulation (3) the following subregulation:

"(3) The number of Board of Directors who may be appointed by the Minister shall not be more than—

(a) four person for the Area Farmers' Organization;

- (b) four person for the State Farmers' Organization;
 - (c) six person for the National Farmers' Organization;
and
 - (d) three person nominated by the Minister of
Modernisation of Agriculture of Sarawak for the
State of Sarawak.”; and
- (c) in subregulation (8), by substituting for the word “eight” the word “nine”.
