CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 2) ORDER 2015

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

Citation

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 2) Order 2015**.

Controlled articles

2. The articles specified in the Schedule are declared to be controlled articles for the period from 22 May 2015 to 2 June 2015.

SCHEDULE

CONTROLLED ARTICLES

1. Imported buffalo meat (India)
2. Imported round cabbage (Indonesia and China, not including Beijing cabbage)
3. Live pig
4. Pork (belly)
5. Pork (lean and fat)
