FEES ACT 1951

FEES (MEDICAL) (FULL PAYING PATIENT) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 3 of the Fees Act 1951 [*Act 209*], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Fees (Medical) (Full Paying Patient) (Amendment) Order 2015**.

(2) This Order comes into operation on 20 May 2015.

**Amendment of First Schedule**

2. The Fees (Medical) (Full Paying Patient) Order 2007 [*P.U. (A) 252/2007*], is amended by substituting for the First Schedule the following Schedule:
