IMMIGRATION ACT 1959/63 AND PASSPORTS ACT 1966

IMMIGRATION AND PASSPORTS (WANG KELIAN FREE FLOW ZONE) (EXEMPTION)
(REVOCATION) 2015

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [Act 155] and section 4 of the Passports Act 1966 [Act 150], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Immigration and Passports (Wang Kelian Free Flow Zone) (Exemption) (Revocation) 2015**.

(2) This Order comes into operation on 1 April 2015.

Revocation

2. The Immigration and Passport (Wang Kelian Free Flow Zone) (Exemption) Order 2009 [P.U. (A) 243/2009] is revoked.
