AKTA PENGANGKUTAN AWAM DARAT 2010

PERATURAN-PERATURAN PENGANGKUTAN AWAM DARAT  
[KAEDAH-KAEDAH LEMBAGA PELESENAN KENDERAAN PERDAGANGAN  
(KADAR TAMBANG) (PINDAAN) 2015] 2015

PADA menjalankan kuasa yang diberikan oleh perenggan 252(1)(t) Akta Pengangkutan Awam Darat 2010 [*Akta 715*], Menteri atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-Peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pengangkutan Awam Darat [Kaedah-Kaedah Lembaga Pelesenan Kenderaan Perdagangan (Kadar Tambang) (Pindaan) 2015] 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 19 Mac 2015.

**Pindaan Jadual Pertama**

2. Kaedah-Kaedah Lembaga Pelesenan Kenderaan Perdagangan (Kadar Tambang) 2000 [*P.U. (A) 242/2000*] dipinda dalam Jadual Pertama di bawah kepala “BAHAGIAN I—SEMENANJUNG MALAYSIA” dalam subperenggan 2(b), di bawah ruang “Kadar Tambang (setiap penumpang)”, dengan menggantikan perkataan “tidak melebihi 8.5 sen untuk setiap kilometer atau sebahagian daripadanya dikenakan kepada 10 sen terdekat” dengan perkataan “tidak melebihi 11.4 sen bagi setiap kilometer atau sebahagian daripadanya dikenakan kepada 10 sen yang terdekat”.

LAND PUBLIC TRANSPORT ACT 2010

LAND PUBLIC TRANSPORT [COMMERCIAL VEHICLES LICENSING BOARD  
(RATES OF FARE) (AMENDMENT) RULES 2015] REGULATIONS 2015

IN exercise of the powers conferred by paragraph 252(1)(t) of the Land Public Transport Act 2010 [Act 715], Minister on the recommendation of the Commission, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Land Public Transport [Commercial Vehicles Licensing Board (Rates of Fare) (Amendment) Rules 2015] Regulations 2015**.

(2) These Regulations come into operation on 19 March 2015.

**Amendment of First Schedule**

2. The Commercial Vehicles Licensing Board (Rates of Fare) Rules 2000 [P.U. (A) 242/2000] are amended in the First Schedule under the heading "PART I—PENINSULAR MALAYSIA" in subparagraph 2(b), under the column "Rates of Fare (per passenger)", by substituting for the words "not more than 8.5 sen for each kilometre or part thereof rounded up to the nearest 10 sen" the words "not more than 11.4 sen for each kilometre or part thereof rounded up to the nearest 10 sen".
