PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) 2015

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 2 Februari 2015.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2015**.

(2) This Order comes into operation on 2 February 2015.

Amendment of Second Schedule

2. The Customs (Prohibition of Imports) Order 2012 [*P.U. (A) 490/2012*] is amended in the Second Schedule—

(a) in Part I, by inserting after item 9 and the particulars relating to it the following item:

(1) <i>Item</i>	(2) <i>Description of Goods</i>	(3) <i>Chapter/ Heading/ Subheading</i>	(4) <i>Country</i>	(5) <i>Ministry/Department/Statutory Body Issuing Licence</i>
"10.	Waste, parings and scrap of plastics	39.15	All countries	Department of National Solid Waste Management"; and

(b) in Part II, by deleting item 19 and the particulars relating to it.
