1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Damansara-Puchong) (Pindaan) 2014**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2015.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Damansara-Puchong) 1999 [*P.U. (A) 27/1999*], dipinda dalam Jadual Pertama—

(a) dalam Bahagian I, dalam tajuk—

(i) dengan memotong perkataan “BAHAGIAN I”; dan

(ii) dengan menggantikan perkataan “31 DISEMBER 2010” dengan perkataan “30 JUN 2015”; dan

(b) dengan memotong BAHAGIAN II dan BAHAGIAN III.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(DAMANSARA-PUCHONG HIGHWAY) (AMENDMENT) ORDER 2014

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Damansara-Puchong Highway) (Amendment) Order 2014**.

(2) This Order comes into operation on 1 January 2015.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Damansara-Puchong Highway) 1999 [*P.U. (A) 27/1999*], is amended in the First Schedule—

(a) in Part I, in the heading—

(i) by deleting the words “PART I”; and

(ii) by substituting for the words “31 DECEMBER 2010” the words “30 JUNE 2015”; and

(b) by deleting PART II and PART III.
