(2) Perintah ini mula berkuat kuasa pada 1 Januari 2015.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway-Kerinchi Link and Damansara Link) (Amendment) Order 2014**.

(2) This Order comes into operation on 1 January 2015.

**Amendment of Second Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway-Kerinchi Link and Damansara Link) Order 2001 [*P.U. (A) 274/2001*], is amended in the Second Schedule—

(a) in Part I, in the heading—

(i) by deleting the words “PART I”; and

(ii) by substituting for the words “31 DECEMBER 2009” the words “30 JUNE 2015”; and

(b) by deleting PART II, PART III and PART IV.
