PERINTAH PERKHIDMATAN KEWANGAN ISLAM (AMAUN MINIMUM DANA MODAL)  
(ORANG YANG DILULUSKAN) (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh subseksyen 12(1) Akta Perkhidmatan Kewangan Islam 2013 [*Akta 759*], Bank membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

## ISLAMIC FINANCIAL SERVICES ACT 2013

ISLAMIC FINANCIAL SERVICES (MINIMUM AMOUNT OF CAPITAL FUNDS)  
(APPROVED PERSON) (AMENDMENT) ORDER 2014

IN exercise of the powers conferred by subsection 12(1) of the Islamic Financial Services Act 2013 [Act 759], the Bank makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Islamic Financial Services (Minimum Amount of Capital Funds) (Approved Person) (Amendment) Order 2014**.

(2) This Order comes into operation on 1 January 2015.

**Amendment of Schedule 1**

2. The Islamic Financial Services (Minimum Amount of Capital Funds) (Approved Person) Order 2013 [*P.U. (A) 210/2013*] is amended in Schedule 1 by substituting for item “Approved Islamic financial adviser” and the particulars relating to it the following item and particulars:
