FINANCIAL SERVICES (MINIMUM AMOUNT OF CAPITAL FUNDS) (APPROVED PERSON)
(AMENDMENT) ORDER 2014

IN exercise of the powers conferred by subsection 12(1) of the Financial Services Act 2013 [*Act 758*], the Bank makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Financial Services (Minimum Amount of Capital Funds) (Approved Person) (Amendment) Order 2014**.

(2) This Order comes into operation on 1 January 2015.

Amendment of Schedule 1

2. The Financial Services (Minimum Amount of Capital Funds) (Approved Person) Order 2013 [*P.U. (A) 204/2013*] is amended in Schedule 1 by substituting for item "Approved financial adviser" and the particulars relating to it the following item and particulars:
