FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(SOUTH KLANG VALLEY EXPRESSWAY) (AMENDMENT) (NO. 2) ORDER 2014

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (South Klang Valley Expressway) (Amendment) (No. 2) Order 2014**.

(2) This Order comes into operation on 1 January 2015.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (South Klang Valley Expressway) Order 2013 [P.U. (A) 309/2013] is amended in the First Schedule in the heading by substituting for the words "31 DECEMBER 2014" the words "30 JUNE 2015".
