AKTA PEMBANGUNAN KEMAHIRAN KEBANGSAAN 2006

PERATURAN-PERATURAN PEMBANGUNAN KEMAHIRAN KEBANGSAAN (PENEPIAN FI KEPADA AHLI PERTUBUHAN ORANG CACAT PENGLIHATAN MALAYSIA, CAWANGAN SARAWAK) 2014

PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Ahli Pertubuhan Orang Cacat Penglihatan Malaysia, Cawangan Sarawak) 2014.**

**Penepian fi**

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam butiran 3(a)(ii) Jadual kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2006 [*P.U. (A) 409/2006*] diketepikan berkenaan dengan seseorang ahli Pertubuhan Orang Cacat Penglihatan Malaysia, Cawangan Sarawak yang memohon bagi pengiktirafan pencapaian kemahiran terdahulu yang membawa kepada anugerah Sijil Kemahiran Malaysia.

(2) Penepian fi di bawah subperaturan (1) terpakai bagi permohonan pengiktirafan pencapaian kemahiran terdahulu yang dibuat dalam tempoh tiga tahun mulai 1 Januari 2015 hingga 31 Disember 2017 berhubung dengan bidang urut terapi yang memenuhi kehendak Standard berkaitan.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT (WAIVER OF FEE TO MEMBER OF SOCIETY OF THE  
BLIND IN MALAYSIA, SARAWAK BRANCH) REGULATIONS 2014

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **National Skills Development (Waiver of Fee to Member of Society of the Blind in Malaysia, Sarawak Branch) Regulations 2014**.

**Waiver of fee**

2. (1) Subject to subregulation (2), the fee prescribed in item 3(a)(ii) of the Schedule to the National Skills Development (Fees and Charges) Regulations 2006 [P.U. (A) 409/2006] is waived in respect of a member of the Society of the Blind in Malaysia, Sarawak Branch who applies for the recognition of prior skills achievement leading to the award of the Malaysian Skills Certificate.

(2) The waiver of fee under subregulation (1) applies to the application for the recognition of prior skills achievement made within the period of three years from 1 January 2015 to 31 December 2017 in relation to the field of massage therapy which satisfies the requirements of the relevant Standards.
