AKTA PERKHIDMATAN KEWANGAN DAN SEKURITI LABUAN 2010

PERATURAN-PERATURAN PERKHIDMATAN KEWANGAN DAN SEKURITI LABUAN
(PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 196 Akta Perkhidmatan Kewangan dan Sekuriti Labuan 2010 [*Akta 704*], Menteri, atas syor Lembaga, membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkhidmatan Kewangan dan Sekuriti Labuan (Pindaan) 2014**.

Pindaan Jadual Ketiga

2. Peraturan-Peraturan Perkhidmatan Kewangan dan Sekuriti Labuan 2010 [*P.U. (A) 416/2010*] dipinda dalam Jadual Ketiga—

- (a) dengan menggantikan subsubbutiran 5(*k*)(i) dan (ii) dan butir-butir yang berhubungan dengannya dengan subsubbutiran dan butir-butir yang berikut:

<i>Butiran</i>	<i>Fi</i> <i>(USD/RM)</i>
“(i) perniagaan insurans am atau perniagaan insurans am semula;	USD15,000/RM50,000
(ii) perniagaan insurans nyawa atau perniagaan insurans nyawa semula;	USD15,000/RM50,000”;

- (b) dengan menggantikan subbutiran 5(l) dan butir-butir yang berhubungan dengannya dengan subbutiran dan butir-butir yang berikut:

<i>Butiran</i>	<i>Fi</i> <i>(USD/RM)</i>
“(l) pengurus insurans Labuan termasuklah pengurus insurans diurus;	USD6,500/RM20,000”;

- (c) dengan menggantikan subbutiran 5(m) dan butir-butir yang berhubungan dengannya dengan subbutiran dan butir-butir yang berikut:

<i>Butiran</i>	<i>Fi</i> <i>(USD/RM)</i>
“(m) pengurus pengunderaitan Labuan termasuklah pengurus pengunderaitan diurus;	USD6,500/RM20,000”; dan

- (d) dengan memasukkan selepas subbutiran 5(p) dan butir-butir yang berhubungan dengannya subbutiran dan butir-butir yang berikut:

<i>Butiran</i>	<i>Fi</i> <i>(USD/RM)</i>
“(q) Kesemua entiti berlesen selain daripada yang disebut dalam subbutiran 5(h) dan (i)— sebagai tambahan kepada fi lesen tahunan bagi entiti berlesen tersebut, jika terpakai—	

(i) bagi setiap pejabat yang ditubuhkan untuk operasi entiti berlesen tersebut dalam Malaysia di luar Labuan;	USD3,500/RM10,000
(ii) bagi setiap pejabat pemasaran entiti berlesen tersebut yang ditubuhkan dalam Malaysia di luar Labuan.	USD2,500/RM7,500".

LABUAN FINANCIAL SERVICES AND SECURITIES ACT 2010

LABUAN FINANCIAL SERVICES AND SECURITIES (AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by section 196 of the Labuan Financial Services and Securities Act 2010 [Act 704], the Minister, on the recommendation of the Authority, makes the following regulations:

Citation

1. These regulations may be cited as the **Labuan Financial Services and Securities (Amendment) Regulations 2014**.

Amendment of Third Schedule

2. The Labuan Financial Services and Securities Regulations 2010 [P.U (A) 416/2010] are amended in the Third Schedule—

(a) by substituting for subsubitems 5(k)(i) and (ii) and the particulars relating to it the following subsubitems and particulars:

<i>Item</i>	<i>Fee (USD/RM)</i>
“(i) general insurance business or general reinsurance business;	USD15,000/RM50,000
(ii) life insurance business or life reinsurance business;	USD15,000/RM50,000”;

- (b) by substituting for subitem 5(l) and the particulars relating to it the following subitem and particulars:

<i>Item</i>	<i>Fee</i> <i>(USD/RM)</i>
“(l) Labuan insurance manager including managed insurance manager;	USD6,500/RM20,000”;

- (c) by substituting for subitem 5(m) and the particulars relating to it the following subitem and particulars:

<i>Item</i>	<i>Fee</i> <i>(USD/RM)</i>
“(m) Labuan underwriting manager including managed underwriting manager;	USD6,500/RM20,000”; and

- (d) by inserting after subitem 5(p) and the particulars relating to it the following subitem and particulars:

<i>Item</i>	<i>Fee</i> <i>(USD/RM)</i>
“(q) All licensed entities apart from those mentioned in subitems 5(h) and (i)— in addition to annual licence fee for the licensed entities, where applicable—	

(i) for each office established for the operation of the licensed entities in Malaysia outside Labuan;	USD3,500/RM10,000
(ii) for each marketing office of the licensed entities established in Malaysia outside Labuan.	USD2,500/RM7,500”.
