DENTAL ACT 1971

DENTAL (PUBLIC SERVICE EXEMPTION) ORDER 2014

IN exercise of the powers conferred by paragraph 49(1)(a) of the Dental Act 1971 [Act 51], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Dental (Exemption of Public Service Period) Order 2014**.

**Exemption**

2. The Minister grants a complete exemption to the persons named in the Schedule from undergoing the period of public service required under section 48 of the Act.
