2. Perintah Kualiti Alam Sekeliling (Pewakilan Kuasa) (Penyiasatan ke atas Kawalan Hakisan dan Kelodakan) 2012 [*P.U. (A) 436/2012*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 1—

(a) dalam nota bahu, dengan memotong perkataan “dan permulaan kuat kuasa”; dan

(b) dengan memotong perkataan “(1)”.

ENVIRONMENTAL QUALITY (DELEGATION OF POWERS)
(INVESTIGATION ON EROSION AND SEDIMENT CONTROL) (AMENDMENT) ORDER
2014

IN exercise of the powers conferred by subsection 49(1) of the Environmental Quality Act 1974 [*Act 127*], the Director General makes the following order:

Citation

1. This order may be cited as the **Environmental Quality (Delegation of Powers) (Investigation on Erosion and Sediment Control) (Amendment) Order 2014**.

Amendment of paragraph 1

2. Environmental Quality (Delegation of Powers) (Investigation on Erosion and Sediment Control) Order 2012 [*P.U. (A) 436/2012*], which is referred to as the “principal Order” in this Order, is amended in paragraph 1—

(a) in the shoulder note, by deleting the words “and commencement”; and

(b) by deleting the word “(1)”.

Amendment of Schedule

3. The Schedule to the principal Order is amended by deleting the word “Malaysia”.
