PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 9) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Perak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 9) 2014**.

(2) Perintah ini mula berkuat kuasa pada 10 Oktober 2014.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Perak Darul Ridzuan**"—

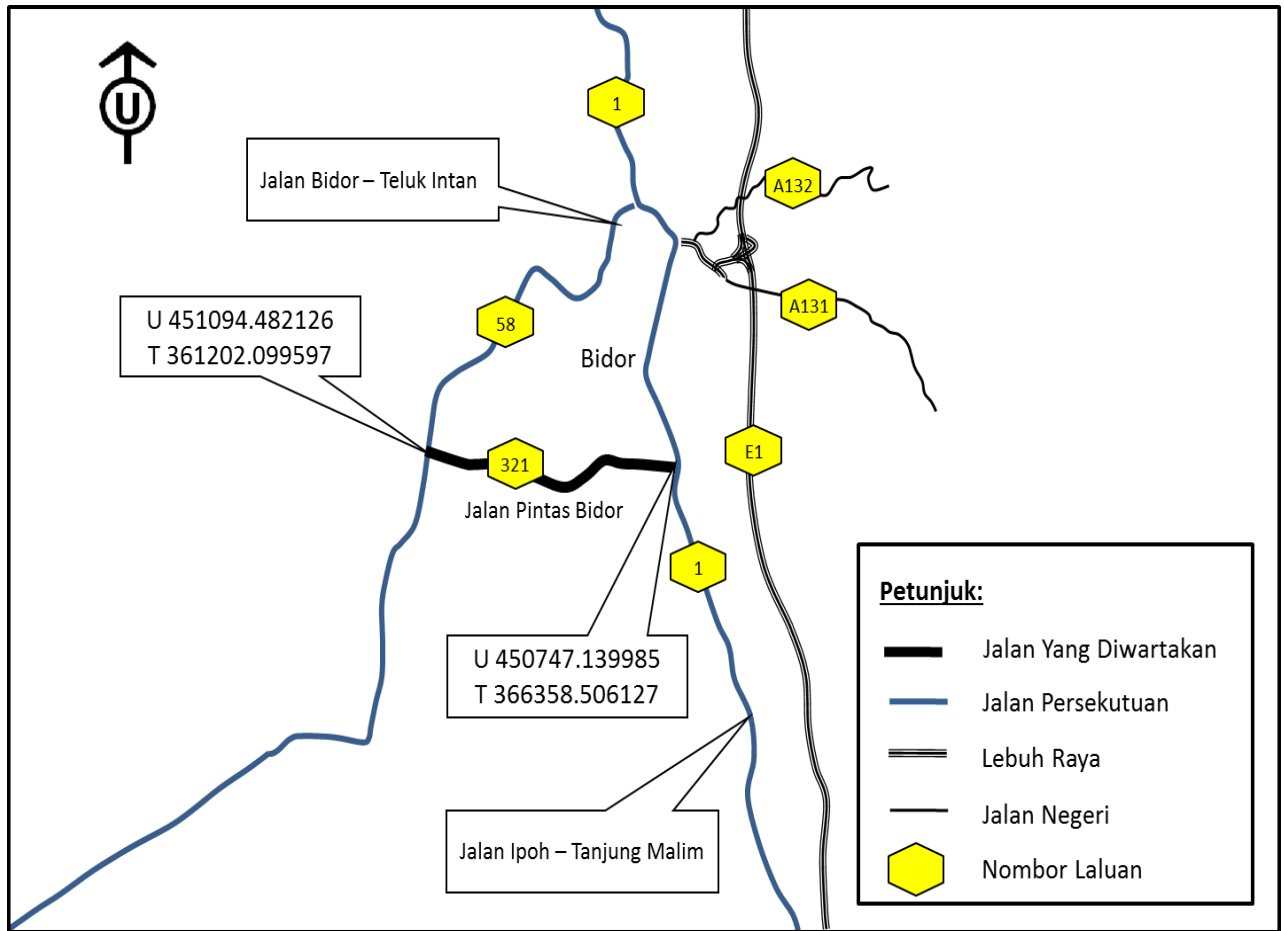
(a) dengan memasukkan selepas butiran 28 butiran yang berikut:

"29. *(Laluan 321): Jalan Pintas Bidor*

Dari persimpangan Jalan Pintas Bidor dengan Laluan 1 Jalan Ipoh – Tanjung Malim di koordinat U 450747.139985, T 366358.506127 dan berakhir di persimpangan Jalan Pintas Bidor dengan Laluan 58 Jalan Bidor – Teluk Intan di koordinat U 451094.482126, T 361202.099597 sebagaimana yang ditunjukkan dalam Peta 12: Jalan-Jalan Persekutuan Negeri Perak (jarak sepanjang 5.45 km)."; dan

(b) dengan memasukkan selepas PETA 11: JALAN-JALAN PERSEKUTUAN NEGERI PERAK peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 9) ORDER 2014

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Perak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 9) Order 2014**.

(2) This Order comes into operation on 10 October 2014.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “**Negeri Perak Darul Ridzuan**”—

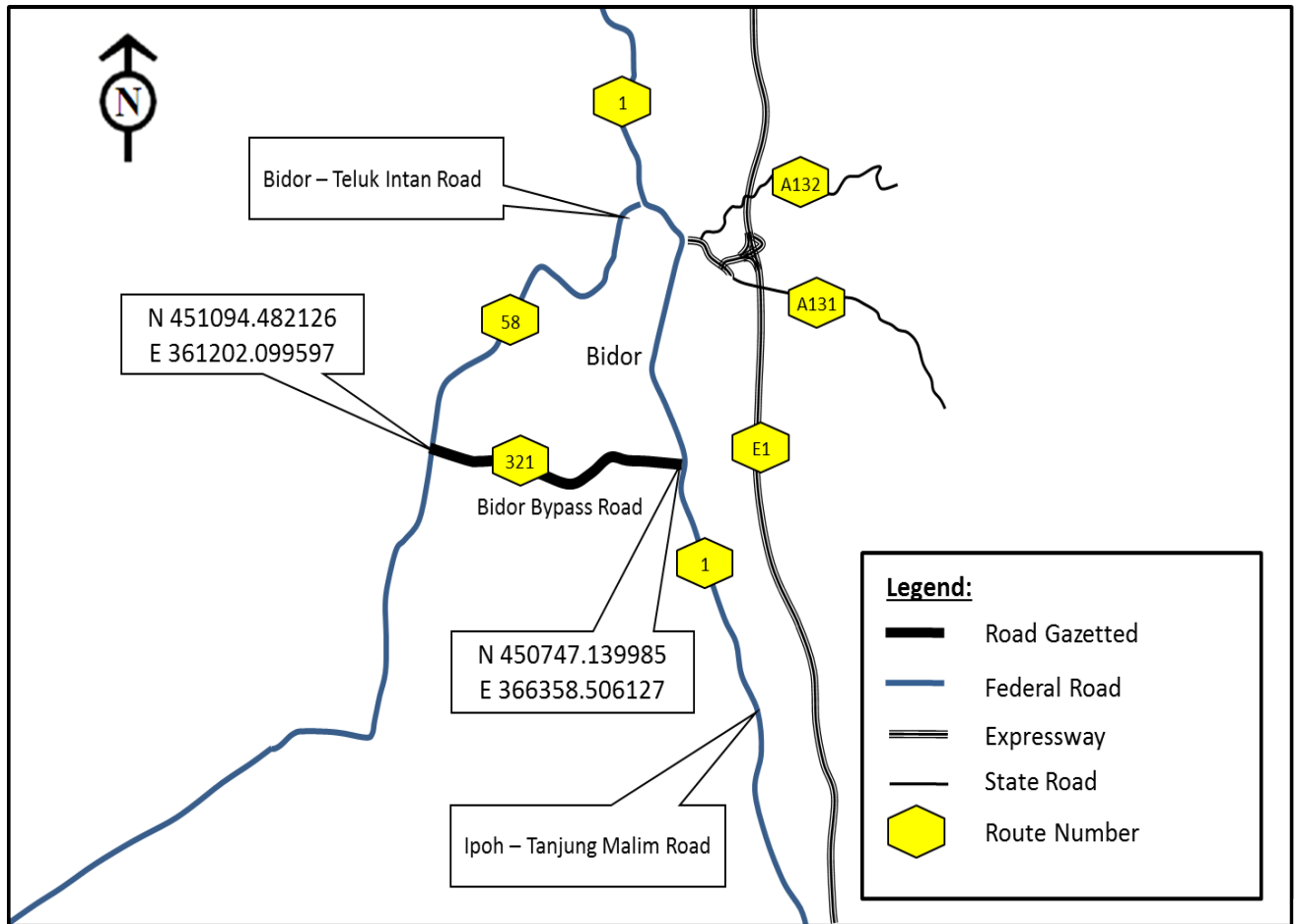
(a) by inserting after item 28 the following item:

“29. *(Route 321): Bidor Bypass Road*

From the junction of Bidor Bypass Road with Route 1 Ipoh – Tanjung Malim Road at coordinates N 450747.139985, E 366358.506127 and ending at the junction of Bidor Bypass Road with Route 58 Bidor – Teluk Intan Road at coordinates N 451094.482126, E 361202.099597 as shown on Map 12: Federal Roads of State of Perak (a distance of 5.45 km).”; and

(b) by inserting after MAP 11: FEDERAL ROADS OF STATE OF PERAK the following map:
