PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 8) 2014**.

(2) Perintah ini mula berkuat kuasa pada 23 September 2014.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Pahang Darul Makmur**"—

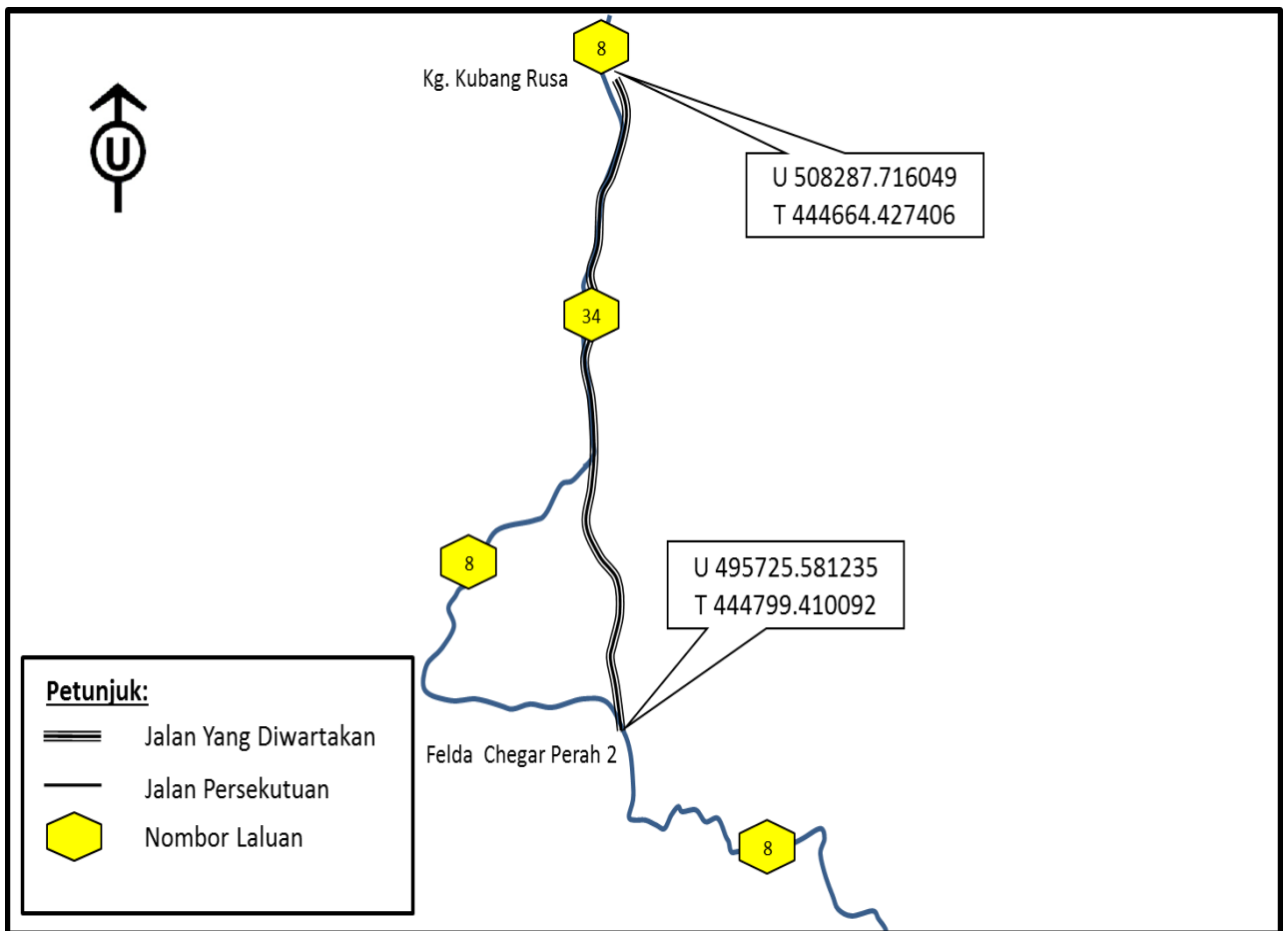
(a) dengan menggantikan butiran 42 dengan butiran yang berikut:

"42. *(Laluan 34): Jalan Central Spine*

Bermula dari Felda Chegar Perah 2 di Laluan 8 di koordinat U 495725.581235, T 444799.410092 dan berakhir di Kg. Kubang Rusa, di koordinat U 508287.716049, T 444664.427406 sebagaimana yang ditunjukkan dalam Peta 21: Negeri Pahang (jarak sepanjang 13.2 km)."; dan

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 8) ORDER 2014

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 8) Order 2014**.

(2) This Order comes into operation on 23 September 2014.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “**Negeri Pahang Darul Makmur**”—

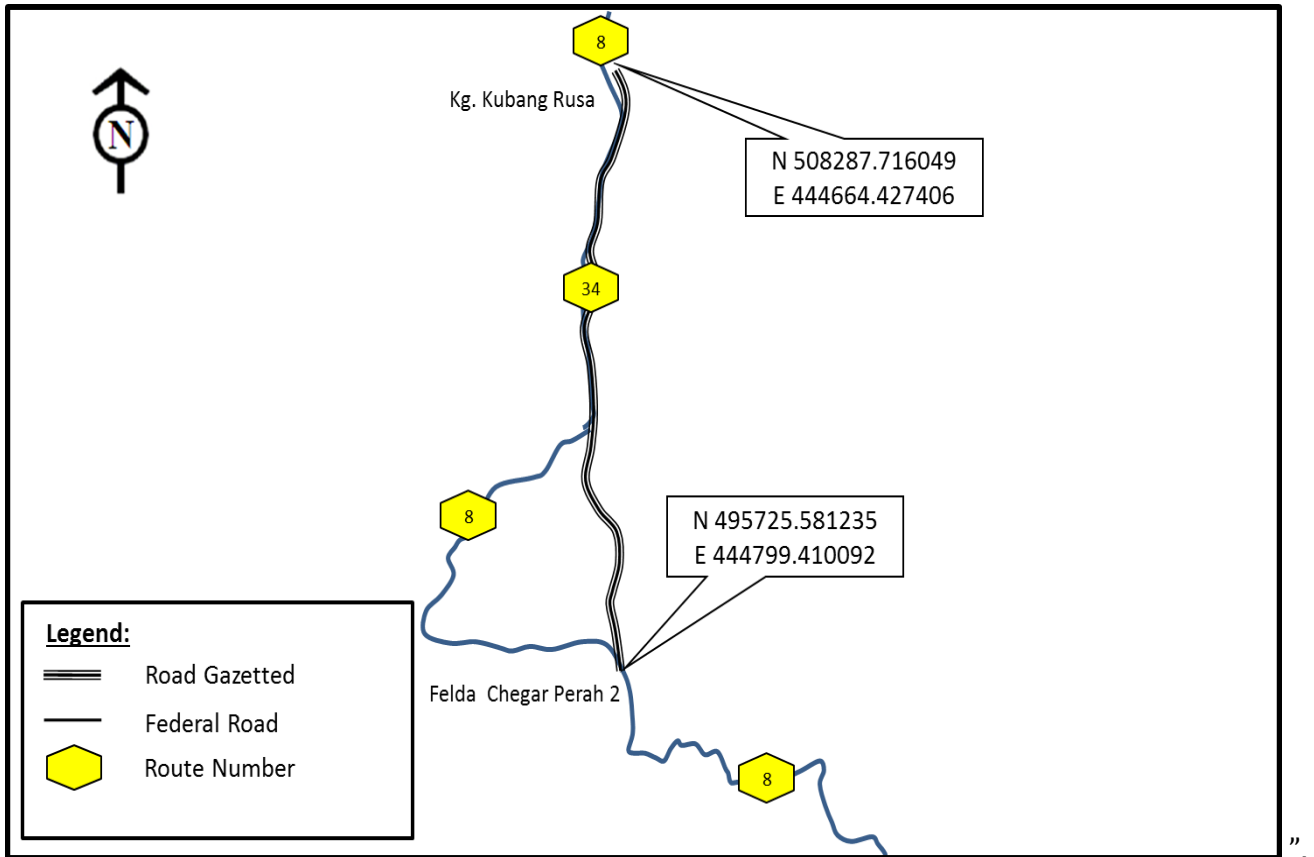
(a) by substituting for item 42 the following item:

“42. *(Route 34): Jalan Central Spine*

Starting from Felda Chegar Perah 2 at Route 8 at coordinates N 495725.581235, E 444799.410092 and ending at Kg. Kubang Rusa, at coordinates N 508287.716049, E 444664.427406 as shown on Map 21 : Negeri Pahang (a distance of 13.2 km).”; and

(b) by substituting for MAP 21: NEGERI PAHANG the following map:
