AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (PINDAAN) (NO. 4) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) (No. 4) 2014**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 10 September 2014.

Pindaan peraturan 3

2. Peraturan-Peraturan Kastam 1977 [P.U. (A) 162/1977], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam peraturan 3—

(a) dalam subperaturan (1), dengan memasukkan selepas proviso (xxiii) proviso yang berikut:

“(xxiv) di Lapangan Terbang Antarabangsa Kuala Lumpur 2 (klia2),
Sepang, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari”;

(b) dalam subperaturan (4), dengan memasukkan selepas proviso (xxiii) proviso yang berikut:

“(xxiv) di Lapangan Terbang Antarabangsa Kuala Lumpur 2 (klia2),
Sepang, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari”; dan

CUSTOMS ACT 1967

CUSTOMS (AMENDMENT) (NO. 4) REGULATIONS 2014

IN exercise of the powers conferred by section 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Amendment) (No. 4) Regulations 2014**.

(2) These Regulations come into operation on 10 September 2014.

Amendment of regulation 3

2. The Customs Regulations 1977 [*P.U. (A) 162/1977*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 3—

(a) in subregulation (1), by inserting after proviso (xxiii) the following proviso:

“(xxiv) at Kuala Lumpur International Airport 2 (klia2), Sepang, the hours shall be—

at all times on any day”;

(b) in subregulation (4), by inserting after proviso (xxiii) the following proviso:

“(xxiv) at Kuala Lumpur International Airport 2 (klia2), Sepang, the hours shall be—

at all times on any day”; and

(c) in subregulation (6), by inserting after proviso (xiii) the following proviso:

“(xiv) at Kuala Lumpur International Airport 2 (klia2), Sepang, the hours shall be—

at all times on any day”.

Amendment of First Schedule

3. The principal Regulations are amended in the First Schedule, in Part IV, under the subheading “States of Malaya” by inserting after the words “Pulau Redang (Terengganu)” and the particulars relating to it the following particulars:

“Kuala Lumpur International Airport 2 (klia2), Sepang	All goods”.
