AKTA PERTUBUHAN PELADANG 1973

PERATURAN-PERATURAN PERTUBUHAN PELADANG (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 35 Akta Pertubuhan Peladang 1973 [*Akta 109*], Lembaga Pertubuhan Peladang, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pertubuhan Peladang (Pindaan) 2014**.

Pindaan peraturan 44

2. Peraturan-Peraturan Pertubuhan Peladang 1983 [*P.U. (A) 303/1983*] yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan (4) dengan menggantikan perkataan “undi” dengan perkataan “undi sulit”.

Pindaan peraturan 45

3. Peraturan 45 dipinda—
 - (a) dalam subperaturan (1), dalam teks bahasa Inggeris dengan menggantikan perkataan “One ballot containing the names of all the candidates to the Board of Directors and another ballot” dengan perkataan “One secret ballot containing the names of all the candidates to the Board of Directors and another secret ballot”;
 - (b) dalam subperaturan (2), dalam teks bahasa Inggeris dengan memasukkan sebelum perkataan “ballot” perkataan “secret”; dan
 - (c) dalam subperaturan (3), dalam teks bahasa Inggeris dengan memasukkan sebelum perkataan “ballot” perkataan “secret”.

Pindaan peraturan 48

4. Peraturan 48 dipinda—

- (a) dalam subperaturan (1), dalam teks bahasa Inggeris dengan menggantikan perkataan “ballot” dengan perkataan “secret vote”; dan
- (b) dengan memotong perenggan (1)(a).

FARMERS' ORGANIZATION ACT 1973

FARMERS' ORGANIZATION (AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by section 35 of the Farmers' Organization Act 1973 [Act 109], the Farmers' Organization Authority, with the approval of the Minister, makes the following regulations:

Citation

1. These regulations may be cited as the **Farmers' Organization (Amendment) Regulations 2014**.

Amendment of regulation 44

2. The Farmers' Organization Regulations 1983 [*P.U. (A) 303/1983*] which are referred to as the "principal Regulations" in these Regulations, are amended in subregulation (4) by substituting for the word "ballot" the words "secret ballot".

Amendment of regulation 45

3. Regulation 45 is amended—

(a) in subregulation (1), in the English language text by substituting for the words "One ballot containing the names of all the candidates to the Board of Directors and another ballot" with the words "One secret ballot containing the names of all the candidates to the Board of Directors and another secret ballot";

(b) in subregulation (2), in the English language text by inserting before the word "ballot" the word "secret"; and

(c) in subregulation (3), in the English language text by inserting before the word "ballot" the word "secret".

Amendment of regulation 48

4. Regulation 48 is amended—

(a) in subregulation (1), in the English language text by substituting for the word “ballot” the words “secret vote”; and

(b) by deleting paragraph (1)(a).
