PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan) (Pelantikan Semula) (No. 2) 2014**.

Pelantikan semula bagi pengambilalihan kawalan

2. Suruhanjaya telah melantik semula Syarikat Rakyat Asset Management Sdn. Bhd. (No. Syarikat 452759-X) iaitu subsidiari kepada Bank Kerjasama Rakyat Malaysia Berhad untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Jimat Cermat Dan Pinjaman Mercantile Berhad dan perbadanan yang berkaitan dengannya, dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya berkuat kuasa mulai 15 Jun 2013 hingga 14 Jun 2014.

Kos dan perbelanjaan

3. Apa-apa kos dan perbelanjaan yang ditanggung oleh Suruhanjaya berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Jimat Cermat Dan Pinjaman Mercantile Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL) (REAPPOINTMENT) (NO. 2)
ORDER 2014

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [*Act 502*], the Commission makes the following order:

Citation

1. This order may be cited as the **Co-operative Societies (Assumption of Control) (Reappointment) (No. 2) Order 2014**.

Reappointment of assumption of control

2. The Commission has reappointed Syarikat Rakyat Asset Management Sdn. Bhd. (Company No. 452759-X) that is a subsidiary of Bank Kerjasama Rakyat Malaysia Berhad to assume control of the whole of the property, business, activities and affairs of the Koperasi Jimat Cermat Dan Pinjaman Mercantile Berhad and its related corporations, and carry on the whole of its business, activities and affairs with effect from 15 June 2013 to 14 June 2014.

Costs and expenses

3. Any costs and expenses incurred by the Commission in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Jimat Cermat Dan Pinjaman Mercantile Berhad as a first charge.
