PERATURAN-PERATURAN EKSAIS (KAWALAN TODI DAN KEDAI TODI)
(PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 39 dan 85 Akta Eksais 1976 [Akta 176], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Eksais (Kawalan Todi dan Kedai Todi) (Pindaan) 2014**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2014.

Pindaan peraturan 4

2. Peraturan-Peraturan Eksais (Kawalan Todi dan Kedai Todi) 1977 [P.U. (A) 157/1977], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam perenggan 4(d), dengan menggantikan perkataan "empat ringgit lima puluh sen" dengan perkataan "sembilan ringgit".

Pindaan peraturan 9

3. Perenggan 9(c) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan "lima belas ringgit" dengan perkataan "tiga puluh ringgit".

EXCISE ACT 1976

EXCISE (CONTROL OF TODDY AND TODDY SHOPS) (AMENDMENT)
REGULATIONS 2014

IN exercise of the powers conferred by sections 39 and 85 of the Excise Act 1976 [Act 176], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Excise (Control of Toddy and Toddy Shops) (Amendment) Regulations 2014**.

(2) These Regulations come into operation on 1 July 2014.

Amendment of regulation 4

2. The Excise (Control of Toddy and Toddy Shops) Regulations 1977 [P.U. (A) 157/1977], which are referred to as the “principal Regulations” in these Regulations, are amended in paragraph 4(d), by substituting for the words “four ringgit and fifty sen” the words “nine ringgit”.

Amendment of regulation 9

3. Paragraph 9(c) of the principal Regulations is amended by substituting for the words “fifteen ringgit” the words “thirty ringgit”.
