PERATURAN-PERATURAN EKSAIS (MEMBOTOL DAN MEMINDAH LIQUOR YANG MEMABUKKAN) (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 85 Akta Eksais 1976 [*Akta 176*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Eksais (Membotol dan Memindah Liquor yang Memabukkan) (Pindaan) 2014**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2014.

2. Peraturan-Peraturan Eksais (Membotol dan Memindah Liquor yang Memabukkan) 1977 [*P.U. (A) 158/1977*] dipinda dengan menggantikan Jadual Tiga dengan Jadual yang berikut:

(Peraturan 6)

Lesen untuk membotol/mencampur/menyebati atau mengubah liquor yang memabukkan	RM2,400.00 untuk tiap-tiap 12 bulan

EXCISE ACT 1976

EXCISE (BOTTLING AND MOVEMENT OF INTOXICATING LIQUORS) (AMENDMENT)
REGULATIONS 2014

IN exercise of the powers conferred by section 85 of the Excise Act 1976 [*Act 176*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Excise (Bottling and Movement of Intoxicating Liquors) (Amendment) Regulations 2014**.

(2) These Regulations come into operation on 1 July 2014.

Amendment of Schedule Three

2. The Excise (Bottling and Movement of Intoxicating Liquors) Regulations 1977 [*P.U. (A) 158/1977*] are amended by substituting for the Schedule Three the following Schedule:

“SCHEDULE THREE
FEES FOR LICENCES
(Regulation 6)

Licence to bottle/blend/compound or vary intoxicating liquors	RM2,400.00 for every 12 months

”.
