AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh subseksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) 2014**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2014.

Pindaan peraturan 19

2. Peraturan-Peraturan Kastam 1977 [*P.U. (A) 162/1977*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 19(1)—

(a) dengan menggantikan perkataan “\$10” dengan perkataan “RM20.00”; dan

(b) dengan menggantikan perkataan “\$48” dengan perkataan “RM96.00”.

Pindaan peraturan 25

3. Subperaturan 25(3) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan “\$20” dengan perkataan “RM40.00”.

CUSTOMS ACT 1967

CUSTOMS (AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by subsection 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Amendment) Regulations 2014**.

(2) These Regulations come into operation on 1 July 2014.

Amendment of regulation 19

2. The Customs Regulations 1977 [*P.U. (A) 162/1977*], which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 19(1)—

(a) by substituting for the words “\$10” the words “RM20.00”; and

(b) by substituting for the words “\$48” the words “RM96.00”.

Amendment of regulation 25

3. Subregulation 25(3) of the principal Regulations is amended by substituting for the words “\$20” the words “RM40.00”.
