FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(SENAI-PASIR GUDANG-DESARU EXPRESSWAY) (AMENDMENT) ORDER 2014

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Senai-Pasir Gudang-Desaru Expressway) (Amendment) Order 2014**.

(2) This Order is deemed to have come into operation on 1 January 2014.

Substitution of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Senai-Pasir Gudang-Desaru Expressway) Order 2011 [P.U. (A) 231/2011] is amended by substituting for the First Schedule the following Schedule:

Class 1 : Vehicles having two axles and three or four wheels (excluding taxis and buses)

Class 2 : Vehicles having two axles and five or six wheels (excluding buses)

Class 3 : Vehicle having three axles or more (excluding buses)

Class 4 : Taxis

Class 5 : Buses

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be included as part of the axles and wheels of the vehicles. ”.
