PADA menjalankan kuasa yang diberikan oleh subseksyen 28B(1) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [Act 504] dan subseksyen 11(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Dipercepat) 2014**.

(2) Perintah ini hendaklah mula berkuat kuasa pada 5 Jun 2014.

Tempoh kajian semula dipercepat

2. Pengenaan duti anti-lambakan di bawah Perintah Kastam (Duti Anti-Lambakan) (No. 3) 2013 [P.U. (A) 339/2013] hendaklah tidak dikenakan kepada Novowell ETP Limited pengeluar *electrolytic tinplate* dari Republik Rakyat China semasa kajian semula dipercepat sedang dijalankan dari 5 Jun 2014 hingga 12 September 2014.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967
CUSTOMS (ANTI-DUMPING DUTIES) (EXPEDITED REVIEW) ORDER 2014

IN exercise of the powers conferred by subsection 28B(1) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Expedited Review) Order 2014**.

(2) This Order shall come into operation on 5 June 2014.

Period of expedited review

2. The imposition of anti-dumping duties under the Customs (Anti-Dumping Duties) (No. 3) Order 2013 [*P.U. (A) 339/2013*] shall not be imposed on Novowell ETP Limited the producer of *electrolytic tinplate* from the People's Republic of China while the expedited review is being carried out from 5 June 2014 until 12 September 2014.
