PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA KORIDOR GUTHRIE) (NO. 2) (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Koridor Guthrie) (No. 2) (Pindaan) 2014**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Januari 2012.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Koridor Guthrie) (No. 2) 2005 [*P.U. (A) 298/2005*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 2(1)—

(a) dengan menggantikan perkataan “ruang (2) Bahagian I hingga IV Jadual Pertama mengikut tahun-tahun konsesi,” dengan perkataan “ruang (2) Jadual Pertama”; dan

(b) dengan menggantikan perkataan “ruang (1) Bahagian I hingga IV Jadual Pertama” dengan perkataan “ruang (1)”.

Pindaan Jadual Pertama

3. Jadual Pertama kepada Perintah ibu dipinda—

(a) dalam tajuk—

(i) dengan memotong perkataan “BAHAGIAN I”;

- (ii) dengan memotong perkataan “KONSESI”; dan
 - (iii) dengan menggantikan perkataan “2011” dengan perkataan “2014”;
dan
- (b) dengan memotong BAHAGIAN II, BAHAGIAN III dan BAHAGIAN IV.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(GUTHRIE CORRIDOR EXPRESSWAY) (NO. 2) (AMENDMENT) ORDER 2014

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Guthrie Corridor Expressway) (No. 2) (Amendment) Order 2014**.

(2) This Order is deemed to have come into operation on 1 January 2012.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Guthrie Corridor Expressway) (No. 2) Order 2005 [*P.U. (A) 298/2005*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 2(1)—

(a) by substituting for the words “column (2) of Parts I to IV of the First Schedule according to the concession years,” the words “column (2) of the First Schedule”; and

(b) by substituting for the words “column (1) of Parts I to IV” the words “column (1)”.

Amendment of First Schedule

3. The First Schedule to the principal Order is amended—

(a) in the heading—

(i) by deleting the words “PART I”;

(ii) by deleting the word “CONSESSION”; and

(iii) by substituting for the word “2011” the word “2014”; and

(b) by deleting PART II, PART III and PART IV.
