AKTA PEMBANGUNAN KEMAHIRAN KEBANGSAAN 2006

PERATURAN-PERATURAN PEMBANGUNAN KEMAHIRAN KEBANGSAAN
(PENEPIAN FI KEPADA PENGAJAR JABATAN TENAGA MANUSIA) 2014

PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Pengajar Jabatan Tenaga Manusia) 2014**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 April 2014.

Penepian fi

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam butiran 3(a)(ii), 3(b)(ii) atau 3(c)(ii) Jadual kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2006 [*P.U. (A) 409/2006*] diketepikan berkenaan dengan mana-mana pengajar Jabatan Tenaga Manusia yang memohon bagi pengiktirafan pencapaian kemahiran terdahulu yang membawa kepada anugerah Sijil Kemahiran Malaysia, Diploma Kemahiran Malaysia atau Diploma Lanjutan Kemahiran Malaysia, mengikut mana-mana yang berkenaan.

(2) Penepian fi di bawah subperaturan (1) terpakai bagi permohonan pengiktirafan pencapaian kemahiran terdahulu yang dibuat mulai 15 April 2014 hingga 14 April 2019 yang berhubung dengan pengalaman kerja pengajar itu dalam apa-apa bidang—

(a) yang memenuhi kehendak Standard yang berkaitan; dan

(b) bagi suatu tempoh sebagaimana yang ditentukan oleh Ketua Pengarah.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT (WAIVER OF FEE TO INSTRUCTOR
OF MANPOWER DEPARTMENT) REGULATIONS 2014

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Instructor of Manpower Department) Regulations 2014**.

(2) These Regulations come into operation on 15 April 2014.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in item 3(a)(ii), 3(b)(ii) or 3(c)(ii) of the Schedule to the National Skills Development (Fees and Charges) Regulations 2006 [P.U. (A) 409/2006] is waived in respect of any instructor of the Manpower Department who applies for the recognition of prior skills achievement leading to the award of the Malaysian Skills Certificate, Malaysian Skills Diploma or Malaysian Skills Advanced Diploma, as the case may be.

(2) The waiver of fee under subregulation (1) is applicable for the application for the recognition of prior skills achievement made from 15 April 2014 to 14 April 2019 in relation to the working experience of the instructor in any field—

(a) which satisfies the requirements of the relevant Standards; and

(b) for a period as determined by the Director General.
