CONTROL OF PADI AND RICE ACT 1994

CONTROL OF PADI AND RICE (LICENSING OF PADI PURCHASERS) (AMENDMENT)
REGULATIONS 2014

IN exercise of the powers conferred by section 29 of the Control of Padi and Rice Act 1994 [Act 522], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Control of Padi and Rice (Licensing of Padi Purchasers) (Amendment) Regulations 2014**.

Amendment of regulation 3

2. The Control of Padi and Rice (Licensing of Padi Purchasers) Regulations 1996 [P.U. (A) 625/1996] which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 3(1) by deleting the words “, on application in writing,”.

Substitution of Schedule

3. The principal Regulations are amended by substituting for the Schedule the following schedule:
